AN ORDINANCE AUTHORIZING AND DIRECTING PARTICIPATION BY THE TOWN OF FLEMING, COLORADO, IN THE ELECTRICAL RESOURCES POOLING AGREEMENT OF THE MUNICIPAL ENERGY AGENCY OF NEBRASKA; AUTHORIZING AND DIRECTING THE EXECUTION OF THE AGREEMENT; TO PRESCRIBE THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE TOWN OF FLEMING, COLORADO:

- Section 1. The Board of Trustees hereby finds and declares it to be in the public interest and in the interest of the customers of the Town's electric utility that the Town become a party to Electrical Resources Pooling Agreement with the Municipal Energy Agency of Nebraska as a Total Power Requirements Power Participant.
- Section 2. It is hereby ordered and directed that the Town of Fleming, Colorado, acting through its Mayor and Town Clerk, execute the Electrical Resources Pooling Agreement as a Total Power Requirements Power Participant, a copy of said Agreement being attached hereto and made a part hereof.
- Section 3. The City of Fleming, Colorado, does hereby adopt and approve each of the objectives, terms and conditions set forth in the Electrical Resources Pooling Agreement, and Service Schedule M.

Section 4. This ordinance shall be in full force and take effect after its passage, approval and publication as provided by law.
