GRADUATION REQUIREMENTS

Aberdeen School District High School Diploma Requirements

A student's Personal Learning Plan must document a minimum of 25 credits which includes a plan based on a student's skills and interests that identifies the specific coursework a student needs to reach their academic and career goals.

Advanced Endorsements

Within the coursework outlined, a student may earn one (or more) of three advanced endorsements. Advanced endorsements outline specific coursework completed within the general high school diploma requirements to denote particular emphases. (Substitutions noted above with an * do not apply to Advanced and Advanced Honors endorsement requirements.)

- Advanced Endorsement: Indicates a student has pursued coursework consistent with entrance requirements for postsecondary education at a university.
- Advanced Career Endorsement: Indicates a student has career experience in a concentrated area, based on academic and/or workplace experience and a related credential
- Advanced Honors Endorsement: Indicates a student has pursued advanced, rigorous, academic coursework consistent with SDCL 13-55-31.1 (High school course requirements for opportunity scholarship eligibility).

B. CREDIT BY EXAM (COURSE EQUIVALENCY EXAM)

For courses approved by the Department of Education through a waiver process initiated by the District, the District will offer credit by exam for students enrolled in the District in grades 9-12

Course exams will be developed and administered by District certified staff. All exams will be comprehensive in nature and reflect the South Dakota State Standards. Students must pass the exam with at least 85% proficiency on the first attempt for credit to be issued. Credit will be included on the student transcript upon achieving 85% proficiency or above and will be calculated as a part of a student's cumulative grade point average. A student will have a letter grade assigned for the course which reflects the results of the equivalency exam. Failed attempts on the course equivalency exam will not be included on a student's transcript and will not be calculated as a part of a student's cumulative grade point average.

Total credits earned through credit by exam will be limited to 4 credits. All credits received by exam will apply toward the 25 credit requirement.

C. COURSES FOR HIGH SCHOOL CREDIT PRIOR TO NINTH GRADE

Students who take high school courses prior to grade nine, will receive high school credit within the subject area if the course is taught by a teacher with applicable certification, it meets the seat time requirements, and the student passes the course with a final grade of at least a C- prior to the start of the following school year. Upon successfully obtaining a final grade of at least C-, the letter grade will be posted on the student's transcript and the course will be calculated as part of the student's cumulative grade point average. A waiver for credit prior to grade nine must be approved by the State and the District.

D. GRADUATION - SPECIAL EDUCATION STUDENTS

The School Board is committed to all students taking courses that challenge their individual skills. It also recognizes the District's responsibility to provide a free appropriate public education to each student with disabilities based on their individual needs. The Individual Education Plan (IEP) teams will develop a course of study for each student with an IEP to be reviewed a minimum of annually. The course of study will outline the student's coursework toward the South Dakota High School Diploma Requirements and inform decisions based on the individual student's needs including measurable postsecondary goals. The IEP team will determine, document, and ensure parent is informed at least one year in advance that the student will graduate with a regular diploma or continue eligibility for special education services until the earlier of when the student completes his/her secondary school program or the 30th of June following the student's 21st birthday. The Individuals with Disabilities Education Act (IDEA) does not guarantee that every student with a disability will receive a regular high school diploma.

E. GRADUATION CEREMONY

The School District is committed to acknowledging academic achievement and to awarding a high school diploma or certificate of completion to those students who have completed the required coursework for high school graduation.

High school students with twenty-three credits at the end of the third term of their senior year may participate in the graduation ceremony.

Extenuating circumstances may be appealed to the Superintendent.
