



## **RCS Central School District residents to** consider \$53.5 million budget proposal

On Tuesday, May 16, residents of the Ravena-Coeymans-Selkirk Central School District will vote on a proposed \$53,548,486 budget for the 2023-24 school year.

The RCS Board of Education adopted the proposed budget after spending the last few months reviewing programs, considering future opportunities, and finalizing necessities for the coming school year.

The proposed plan includes a spending increase of \$2,291,557 or 4.47%, and would result in an estimated tax rate increase of 1.48%. This estimated tax increase is at the district's tax cap and requires only a simple majority for the budget to be approved (50% plus one vote).

This increase in spending would allow for programming growth throughout the district while continuing to maintain the programs and opportunities that are already in place. One place in particular that would benefit from the increase in spending would be the Career and Technical Education Graduation Pathways. The proposed budget includes the hiring of additional staff who would possess the expertise needed to grow and advance these important programs for our students.



\* In the event that the voters of the Ravena-Coeymans-Selkirk School District fail to approve the proposed budget, the Board of Education would have to adopt a contingent budget or amend the current budget proposal. A contingent budget limits the property tax levy to a zero percent increase. In that event the school would have to eliminate most equipment purchases as well as limit the increase in the administrative portion of the budget. The administrative portion would need to be at or below the same percentage of the current school year.

#### **Voter Eligibility**

A qualified voter is one who is (1) a citizen of the United States of America, (2) eighteen (18) years of age or older, (3) resident within the school district for a period of thirty (30) days preceding the annual vote and election and (4) not otherwise disqualified under the Election Law. # Residents of the Ravena-Coeymans-Selkirk Central School District will vote on the following propositions:

**Proposition 1:** Shall the following resolution be adopted to wit: RESOLVED: That the Board of Education of the Ravena-Coeymans-Selkirk Central School District be authorized to spend a total amount of \$53,548,486 during the school year 2023 - 2024 and levy the necessary tax therefore.

**Bus Purchase Proposition:** Shall the Board of Education of the Ravena-Coeymans-Selkirk Central School District, Albany County, New York, be authorized to (a) purchase three (3) 64-passenger buses at a total price not to exceed \$495,084.14 (after deducting the value of the trade-in vehicles), (b) expend such sums or so much thereof as may be necessary for such purpose; (c) levy the necessary tax, to be levied and collected in such amounts as may be determined by the Board of Education taking into account state aid and monies received on the trade-in of other vehicles; and (d) in anticipation of the collection of such tax, to issue bonds and notes of the district at one time or from time to time in the principal amount not to exceed \$495,084.14, and to levy a tax to pay the interest on such obligations when due.

Capital Reserve Account Referendum: Shall the Board of Education of the Ravena-Coeymans-Selkirk Central School District be authorized to (1) create a Capital Reserve Fund pursuant to Education Law § 3651(1) for the purpose of financing the purchase of, and general improvement, reconstruction, renovations or additions to the district's buildings, including the acquisition of sites (land and/or buildings), site work and the acquisition of original furnishings, equipment, machinery, acquisition and installation of technology equipment, or other apparatus required for the purpose for which such buildings are to be used; (2) the maximum amount for such fund shall be capped at \$10,000,000; (3) deposit into the Capital Reserve Fund such unallocated fund balance of the General Fund as determined by the Board of Education; state aid related to expenditures from the Capital Reserve Fund; and interest income related to investment monies in the fund. The probable duration of the Capital Reserve Fund is ten (10) years. This Capital Reserve Fund is in addition to any existing Capital Reserve Fund not an extension or amendment of any existing Capital Reserve Fund.

**Board of Education Election:** Residents will vote to fill three seats on the Board of Education. Candidates will be elected to three-year terms to begin July 1. Board of Education candidates are listed on the ballot in order based on a random selection process as dictated by law. They are listed in the order in which they were drawn. **Library Vote:** District residents will have the opportunity to elect two (2) trustees to the Board of Trustees of the RCS Community Library for two (2) full three (3) year terms, and vote on the proposed library levy of \$637,297 or a 1.5% increase from the current year.
