Board of Education **REGULAR MEETING MINUTES**

- 1. Mr. Bender led the Pledge of Allegiance and called the meeting to order at 6:00 pm.
- 2. Roll Call: Those present at the meeting were Mr. Bender, Mrs. Quine, Mr. Taylor, Mrs. Georges, Mr. Fehl with Mr. Heuermann and Mrs. Lindsay being absent. Dr. Baele, Ms. Baughman, Lisa Garrett, and Savannah Cheatham were also present.
- 3. Communications / Presentations

- 4. Consent Agenda

ACTION: Mrs. Quine made the motion to approve the consent agenda which included the minutes of the February 27th Regular Meeting and February 27th Closed Session Minutes, the February Financial Report, and the February Treasurer's Report. The motion was seconded by Mr. Taylor and carried with all in favor.

5. March Bills

ACTION: Mrs. Quine made the motion to approve the March bills, seconded by Mrs. Georges. The motion carried with all aye votes.

- 7. Superintendent Report Dr. Baele presented the current enrollment of the district at 273 students with 9 students being served out of district and 14 ECE/PK students. Dr. Baele informed the Board that Oak Grove has 29 pre-enrolled kindergarten which is great news. Dr. Baele also informed the Board of Limestone Area Administrators (LAA) meeting as well the latest IASA regional meeting where communication planning was the topic of discussion. Finally, Dr. Baele highlighted to the Board the library committee's visit to Elmwood and their IDEA studio.
- 8. Principal Report Ms. Baughman informed the Board of 3 students who received one day out of school suspensions. She let the Board know that track and scholastic bowl have begun. She also informed the BOE that we sent Mrs. Z and three students to the Peoria County Teen Summit. Two groups (Ms. Padilla's second grade & Mrs. Schindler's 5th grade) of teachers and students from Oak Grove have been selected to present on technology being used in the classroom at the State Capitol in May. Mrs Kirk and 12 of our junior high students will take part in the NASA 3D-Printing Habitat sponsored by Caterpillar on May 2nd. Brooklin C represented Oak Grove in the Peoria Journal Star Spelling Bee as a 5th grader! The IAR is almost wrapped up and the Illinois Science Assessment will be given in early April.

 - a. Press Packet 100 Mr. Bender informed the Board of Education that Press Packet 100 and the associated policies, exhibits, and administrative procedures are available. The second reading of the policies will be completed in April.

 - a. Midwest Engineering / River City Design Site Proposal

b. Authorization of Interfund Loan – Education Fund to Bond & Interest Fund

ACTION: Mrs. Quine made the motion to authorize an interfund loan in the amount of \$240,000 from the Education Fund to the Bond & Interest Fund, seconded by Mrs. Georges. The motion passed with all aye votes.

c. Resolution of the Board of Education of Oak Grove School District No. 68 authorizing the transfer of the property commonly known as 4812 W. Pfeiffer Road, Bartonville to the Board of Control of the Special Education Association of Peoria County.

ACTION: Mr. Taylor made the motion to approve the resolution of the Board of Education of Oak Grove School District No. 68 authorizing the transfer of the property commonly known as 4812 W. Pfeiffer Road, Bartonville to the Board of Control of the Special Education Association of Peoria County, seconded by Mr. Fehl. The motion passed with all aye votes.

d. Establishment of Escrow Trust Account with Commerce Bank for the School District Number 68, Peoria County, Illinois (the "District") \$240,000 General Obligation Refunding Bonds, Series 2016C (the "Bonds).

ACTION: Mrs. Georges made the motion to provide authorization for the Board President and Board Secretary to execute and provide approval from the Board of Education of Oak Grove School District No. 68 to enter into an escrow agreement with Commerce Bank as part of paying principal and interest remaining on the General Obligation Refunding School Bonds, Series 2016C. Seconded by Mr. Taylor, the motion carried with all aye votes.
