REGULAR MEETING MINUTES

- 1. Mr. Bender led the Pledge of Allegiance.
- 2. Mr. Bender called the meeting to order at 6:01 pm.
- 3. Roll Call: Those present at the meeting were Mr. Bender, Mrs. Quine, Mr. Taylor, Mrs. Georges, and Mr. Heuermann. Dr. Baele, Ms. Baughman, and Ms. Sams were also in attendance.
- 4. Communications / Presentations None
- 5. Consent Agenda

ACTION: Mrs. Lindsay made the motion to approve the consent agenda which included the minutes of the August 23rd Regular Meeting, the July and August Financial Reports, and the August Treasurer's Report. The motion was seconded by Mr. Taylor and carried with all aye votes.

ACTION: Mr. Heuermann made the motion to approve the September bills, seconded by Mr. Taylor. The motion carried with all aye votes with Mrs. Lindsay abstaining.

- 8. Superintendent Report Dr. Baele presented the current enrollment of the district at 260 students with 6 students being served out of district. Dr. Baele informed the Board about the most recent LAA and CIV meetings as well as the administrative academy that he attended regarding the Evidence Based Funding model and the Every Student Succeeds Act. A brief update of technology purchases through the ESSA funds was also presented along with upcoming events.
- 9. Principal Report Ms. Baughman informed the Board of a student suspension to be discussed in closed session and that the baseball team won their first game of the regionals. Ms. Baughman is coordinating indoor sports concession stands for the upcoming seasons through an online signup process with Girls Basketball starting Sept. 27th. She also informed the Board of student participation in the naturalization ceremony held at Bradley University for 4th 8th grade students as well as a student team building program on the morning of the SIP day. Teachers worked in the afternoon of the SIP day on continued curriculum planning and development. The positive rewards program will send K-4 students to Tanner's on 10/15/18.

b. Appointment of IMRF Authorized Agent

ACTION: Mrs. Quine made the motion to approve Kourtni Fink as the IMRF authorized agent for Oak Grove School District #68, seconded by Mr. Heuermann. Motion carried with all aye votes.

12. New Business – Discussion Item(s)

- a. PARCC Scores Ms. Baughman gave an update on the Spring 2018 PARCC assessment scores and compared scores to previous years. We continue to work on the development of our curriculum to better align our instruction and assessment so that our students are achieving success every day, not just this one assessment. The goal of the district is to continue to demonstrate improvement over time concerning this assessment.
- b. ROE HLS Inspection Dr. Baele presented the checklist of items identified as deficient on the latest Health Life Safety walkthrough at both Oak Grove School and the East building. The district has already started working on corrective action and Dr. Baele will keep the building committee up to date on any issues that require substantial funding.

ACTION: Mr. Heuermann made the motion to approve the budget for the 2018-19 school year, seconded by Mrs. Taylor. The motion carried with all aye votes.

b. Technology Lease Agreement - Better Banks

ACTION: Mrs. Georges made the motion to approve the technology lease agreement and resolution approving the 2018-19 dollar buyout technology lease with a principal and interest payment of \$26,344.46 and to authorize the Superintendent to executes said agreement, seconded by Mrs. Heuermann. The motion carried with all aye votes.

c. Extra-Curricular Positions

ACTION: Mrs. Quine made the motion to approve the hire of the following extracurricular positions; Carrie Schindler, Head Speech and Assistant Scholastic Bowl, Nate Darko as Head Girls Basketball, Krysten Wallace as Assistant Girls Basketball, Larry Milsteadt as Head Boys Basketball & 5/6 Grade Basketball, and Nick Hermann as Assistant Boys Basketball. The motion was seconded by Mrs. Lindsay and carried with all aye votes.

- 18. Presentation from Board Members on Non-Agenda Business Mr. Bender informed the Board that Mr. Taylor has received the resignation of Mr. Erik Fehl from the Oak Grove Board of Education. An appointee will be named for the months between now and the next school board election in April of 2019. Mr. Taylor provided an update on the building committees work and progress on projects taking place. Mrs. Quine wanted to thank the baseball coaches for a great year and keeping the focus in the right place and she wanted to make sure to share how wonderful the naturalization ceremony was for all involved, that was a great experience for our students.
