The Board of Trustees of Burton Independent School District met in regular session on Thursday, November 17, 2016 at 6:41 p.m. in the Burton Independent School District Administration Office.

The following business was transacted:

1. The meeting was called to order by President Demetrius Colvin, Sr. A prayer was given by Felton Cox, and the Pledge of Allegiance was led by Felton Cox.

#### 2. Open Forum

Kathy Shedd along with some of her students gave a presentation to demonstrate how they use their chrome book laptops to make virtual notebooks online to keep all of their assignments and notes for class.

3. Election returns were canvassed. A motion was made by Trustee Felton Cox and seconded by Trustee Ande Bostain that the Board of Trustees adopt a resolution canvassing the returns and declaring the results of the bond election.

c. Dr. Kennedy presented the secondary report.

Cash Kunkel placed fourth at the State Cross Country Meet.

The football playoff game on November 18<sup>th</sup> will be in Runge at 7:30 p.m., Burton vs. Kaufer Rivera. If the football team wins, the next playoff game will probably be the Friday after Thanksgiving.

## 5. Superintendent's Report

- a. Dr. Kennedy discussed the Master Facility Site Plan for the district with the board. The board began discussion of what direction they might take after the failure of the eighteen million dollar bond issue that was rejected by the district voters. Board President Demetrius Colvin said that he was in favor of moving forward with another bond election. However, he suggested that improvements be broken into smaller pieces, not the whole pie at once. Felton Cox said that he feels like the board needs to look at possibly keeping the present football field, but relocate the parking area so that classrooms could be built in that area.
- b. Richard Gibbens presented the Way Engineering Report. He reported that Burton ISD saved approximately \$33,000 in energy costs last year. Due to the fact that Burton ISD saved more than the amount predicted by Way, the district received the "Green Pig" award from the state.
- c. The December regular board meeting will held on Thursday, December 15, 2016 at 5:00 p.m.
- d. Dr. Kennedy reported that the Staff Christmas Party will be held on Wednesday, December 14, 2016 at 6:00 p.m. Dinner will be served at 7:00 p.m.
- 6. A motion was made by Mr. Bostain and seconded by Mrs. Lucherk to approve the consent agenda as presented. Motion passed unanimously.
- 7. A motion was made by Mrs. Lucherk and seconded by Mr. Bostain to adopt the board resolution Coalition for Districts Experiencing Value Decline. Motion passed unanimously.

- 8. A motion was made by Mrs. Lucherk and seconded by Mr. Bostain to adopt the Small District Adjustment Resolution. Motion passed unanimously.
- 9. A motion was made by Mr. Cox and seconded by Mr. Bostain to submit the charter school's, UT Tyler Innovation Academy, Statement of Impact form to the Texas Education Agency stating the proposed change for the open-enrollment charter is not expected to impact our school district to a significant degree. Motion passed unanimously.
- 10. A motion was made by Mr. Bostain and seconded by Mrs. Lucherk to adjourn at 8:00 p.m. Motion passed unanimously.
