Albertson reported on HB 3499, which is a grant that provides substantial funding for summer school programs, math consultant hire, substitute teacher hires, classroom

aides, summer school aides, credit retrieval, and application education for bilingual parents as well as students applying for summer work and college. Warner concluded the report by thanking Albertson with great appreciation for all the work that is put into the Title program.
