#### 1. Call to Order

#### 3. Approval of Minutes

3. 1. Budget Committee Meeting #2 - May 18, 2015

Barry Shullanberger moved and Dustin Gustaveson seconded the motion to approve the minutes from Budget Committee Meeting #2 of May 18, 2015 as presented. The motion passed unanimously.

## 4. Operating Procedures

Presenter: CHAIR

- 4. 1. A quorum of six budget committee members must be present to conduct the business of the budget committee
- 4. 2. Any member may call for a "straw vote" to include, adjust, or delete items or amount of money from the proposed budget. The majority of votes will decide the action taken.
- 4. 3. All committee members are encouraged to request additional information or to give opinion on any item.
- 4. 4. Salaries (Object 100) and benefits (Object 200) are the responsibility of the Board of Directors and are subject to ratified collective bargaining agreements.

#### 5. Fund 450 - Review Corrections

#### 6. Fund 273

Presenter: JANET MELSNESS

Melsness advised that these are not new funds, they have been separated out to allow for better tracking.

#### 7. Fund 274

Presenter: JANET MELSNESS

#### 8. Fund 280

Presenter: JANET MELSNESS

Melsness advised that this was used for carryover funds in prior years so it is difficult to compare. These dollars were also lumped with 273 and 274 but have been separated out now. It is a rough estimate but could be less. She noted that this fund is strictly salary.

#### 9. Fund 290

**Presenter: JANET MELSNESS** 

Melsness stated that you cannot compare 13-14 and 15-16 as they were carryover funds. 15-16 is a whole new grant. She added that this fund is strictly salary.

## 10. Fund 292

**Presenter: JANET MELSNESS** 

Melsness advised that these are carryover dollars. Anticipating roughly \$22,000 carryover.

#### 11. Fund 293

**Presenter: JANET MELSNESS** 

Melsness advised this is a title grant, will be a new grant coming in during 15-16.

#### 12. Fund 295

Presenter: JANET MELSNESS

Melsness noted that she budgeted \$5,000 at the recommendation of Susan Warner, but

that figure may be a little low.

#### 13. Fund 296

Presenter: JANET MELSNESS
Carryover dollars from IIA and VIB.

#### 14. Fund 298

Presenter: JANET MELSNESS

Melsness stated that this is the Wellness grant. 15-16 will be the last year they receive the grant. She noted that it runs on a calendar year rather than a fiscal year. January of 2016 the remainder of the funds will come in. By the end of this year we will implement a sustainability plan.

#### 15. Fund 410

Presenter: JANET MELSNESS

Melsness noted that bus depreciation is included in this fund. She advised the budget committee that during the work session the board felt strongly that a new district wide telephone system with an intercom system for the elementary schools is a high priority. We are looking into a possible lease or other payment plan options.

#### 16, Fund 450

Presenter: JANET MELSNESS

Melsness advised that the board met during work session on June 1, 2015 and made some adjustments to the priorities for the maintenance reserve fund. The bleachers were added so that we can save money by doing them together. The bus maintenance facility has been left in. They are trying to figure out how to do this along with the bleachers. AD Hay and Fremont are budgeted \$10,000 for painting. The board had a lengthy discussion about the Ag shop, moving the greenhouse and completing the paint shop. These items are included in the budget.

## 17. Fund 499

Presenter: JANET MELSNESS

Melsness would like to get windows installed at AD Hay with these funds but it requires prior approvals. She will begin working on this project in the near future.

#### 18. Fund 600

Presenter: JANET MELSNESS

Melsness stated that HRA's run through this fund. This stayed status quo through October. She added that she doesn't anticipate anything different from the prior year in this fund.

## 19. Fund 601

Presenter: JANET MELSNESS

Melsness advised the group that this is a new fund for tuition reimbursement; this was previously included in Fund 100. A carryover of \$6,778 should have been reflected in 14-15

and the district then adds \$9,000 each year. Any unused funds will carry forward year to year for tuition reimbursement.

#### 20. Fund 700

Presenter: JANET MELSNESS

Melsness stated that this remained status quo at \$10,000.

#### 21. Fund 701

Presenter: JANET MELSNESS

Melsness stated that this is a new building fund. She left it status quo at \$30,000.

## 22. Review of all Funds

Presenter: JANET MELSNESS

Melsness reviewed the changes and transfers made from the prior meetings and the new funds established moving forward. There were no additional questions.

## 23. Public Input & Discussion

Presenter: CHAIR

Barry Shullanberger moved and Teresa Decker seconded the motion to approve the 2015-16 budget of \$11,498,690 as presented. The motion passed unanimously.

Teresa Decker moved and Desi Zamudio seconded the motion to approve the levied permanent rate as it has been set and passed. The motion passed unanimously.
