AN ORDINANCE PROVIDING FOR THE VACATION OF A PORTION OF
SOUTH RAILWAY STREET LYING NORTH OF LOT TWENTY-FIVE (25),
BLOCK Four (4), DUNN'S ADDITION TO THE TOWN OF FLEMING,
LOGAN COUNTY, COLORADO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF FLEMING,
COLORADO:

That the portion of South Railway Street lying North of Lot
Twenty-five (25), Block Four (4), Dunn's Addition to the Town of
Fleming, Colorado, hereinafter more particularly described, be
vacated, to-wit:

Beginning at the Northeast corner of Lot Twenty-five
(25), Block Four (4), Dunn's Addition to the Town of
Fleming, Colorado; thence in a Northwesterly direction
and along the Northwesterly line of said Lot Twenty-five
(25) to the Northwest corner ~~XXXX~~ of said Lot Twenty-five
(25); thence due North and along the West line of said Lot
Twenty-five (25) extended, a distance of fifteen (15)
feet; thence in a Southeasterly direction and parallel with
the North line of said Lot Twenty-five (25) to a point on
the East line of said Lot Twenty-five (25) as extended,
and thence due South a distance of Fifteen (15) feet
to the Northeast corner of Lot Twenty-five (25), the place
of beginning.

TO THE HONORABLE MAYOR and BOARD OF TRUSTEES

of the TOWN OF FLEMING, COLORADO:

The undersigned, owner of the property known and described as Lot Twenty-five (25) in Block Four (4), Dunn's Addition to the Town of Fleming, Logan County, Colorado, does hereby respectfully petition the Board of Trustees of the Town of Fleming, Colorado, to vacate a portion of the street known as South Railway Street, the same being the tract more particularly described as follows, to-wit:

Beginning at the Northeast corner of Lot Twenty-five (25), Block Four (4), Dunn's Addition to the Town of Fleming, Colorado; thence in a Northwesterly direction and along the Northwesterly line of said Lot Twenty-five (25) to the Northwest corner of said Lot Twenty-five (25); thence due North and along the West line of said Lot Twenty-five (25) extended, a distance of fifteen (15) feet; thence in a Southeasterly direction and parallel with the North line of said Lot Twenty-five (25) to a point on the East line of said lot Twenty-five (25) as extended, and thence due South a distance of fifteen (15) feet to the Northeast corner of Lot Twenty-five (25), the place of beginning.

In support of said application, petitioner respectfully presents the following facts:

That the tract of land on which vacation is sought is now, and for many years last past has been, occupied and used by petitioner as the owner of Lot Twenty-five (25), Block Four (4), Dunn's Addition to the Town of Fleming, Colorado.

That the undersigned is the only person affected in any manner by such vacation, and is the only person interested in said petition, and that it is greatly to the interests of the undersigned petitioner that the portion of property above set out be vacated as a public street.

WHEREFORE, Your petitioner respectfully prays that the said tract above-described may be vacated.
