- **Enrollment Update:** Enrollment is up substantially from last year. There are waiting list in all elementary and middle school classrooms. We are looking at having over 300 students to start the school year.
- **COVID Update:** Mr. Smith took suggestions from the board to help draft a letter he would like to send to families, outlining more concrete answers to the questions asked during the Community Forum. Mr. Smith plans to send a draft of the letter to board members for proofing before sending it out. Suggestions from the board also included doing a weekly update to be posted on the District Website and Facebook page. Mr. Smith and the Board agreed that it is very important to keep very clear lines of communication with our families and community.

- **PERS Pension Bond Update:** Denyce Kelly updated the board on the sale of the PERS Pension Bonds. She provided a handout with the breakdown of the sale. She indicated that the sale went very well. The District locked in a True Interest Cost of 2.523%, which was well under the maximum of 4.5% the Board had set. The District will save about 1.3 million over the 20-year life of the bond. The Bond will close on August 19<sup>th</sup> and the District should start to see lower rates with the September payroll.
