## **InterMountain ESD Talking Points**

Superintendent Waite reported that the Crystal Apple Awards were presented May 8<sup>th</sup> at Eastern Oregon University. Dawn Treat and Rheadean Hays were recognized for their service to Imbler. It was also reported that IMESD will be offering several summer professional development opportunities for educators. A detailed list of courses was provided. Mr. Waite noted that a few of our teachers will be taking advantage of the courses at no cost.

#### Maintenance/Transportation Report

Drew Williams reported that Bus #26 is at the body shop and should be done this week. Mr. Williams reported that the plumbing for the locker rooms has been approved and the conduit has been laid. Forms have been set and the concrete should be poured next week. Kaiger Braseth expressed his concern about the cracks in the asphalt on the playground. He stated he has seen delivery trucks turning around on the asphalt which is probably causing the cracks. Mr. Williams stated he would get the cracks sealed and visit with drivers to prevent further damage.

#### **Principal/Activity Report**

Mr. Mills reported that the senior project presentations took place recently with 17 presentations. Four students had to present their project a 2<sup>nd</sup> time, but in the end, they all passed. Eighth Grade Graduation took play the previous Friday. There were a lot of great messages from their parents along with a few embarrassing ones. ## **Superintendent Report**

Superintendent Waite reported that the Elementary Music and Band Concerts were held and the students performed well. Staff were recognized by the District and Boosters during Staff Appreciation Week. He noted that he is thankful to have such a great staff and was happy to celebrate them. The 3<sup>rd</sup> Graders finished their swimming lessons the previous week. Superintendent Waite thanked Mrs. Gray and her student teacher, Kolbe Bales, for putting the lessons together. While it is a lot of work, it is very beneficial for the students.

The fifth grade finished their outdoor school activities. They took three separate day trips that were very engaging and educational. He commended Mr. Bennett for providing the opportunity for his students. Plans are in the works now for a three day - two night outdoor school in the fall. Cove Play Day was held the previous Thursday with the primary grades having their own field day with the help of the middle school and high school students.

Superintendent Waite reported that all parents at the elementary have been contacted to determine whether they are returning. There are a couple of classes that are at capacity, but it is possible to add at other grade levels. It appears the smallest class next year will be the 1<sup>st</sup> grade. Kindergarten Round Up was held the previous week and Kindergarten Jump Start will be August 7-10. Jenn Goodman will be providing some reading activities over the summer. This was well-attended last summer and she is hoping that she will have good participation this year as well.

## **Action Items**

## **Approve Staff Hiring**

Superintendent Waite recommended the hiring of the following individuals: Cambree Sheilds, Assistant Track Coach; Alix Dinsmore, Jr. High Math/Science Instructor; and Celine Burke, Music Instructor. He reported that Mrs. Dinsmore is working on getting the proper certification and currently teaches 6<sup>th</sup> Grade Science in Vale along with coaching middle school tennis. Ms. Burke has nearly completed her Master's Degree and is very active in the Grande Ronde Symphony and teaching African Drumming. She is excited to build the music program.

Kaiger Braseth moved to approve the staff hiring as presented. Ken Patterson seconded the motion, which passed unanimously.

## **Approve Staff Resignations**

Letters of resignation were presented from Memory Donohoe, Paraprofessional and Sydney Treat, Head Jr. High Volleyball Coach. Both staff members are relocating out of the area. Ken Patterson moved to approve the staff resignations. Joe Fisher seconded the motion, which passed unanimously.

# **Approve Math Curriculum**

Superintendent Waite reported that a team comprised of Jillian Gray, Heidi Bowers, Barry Bowers and Katie Burright reviewed the state approved math curriculum options. They have selected Big Ideas through Cengage Learning. It meets the state requirements and is reasonably priced. Jason Beck moved to approve the recommended math curriculum. Joe Fisher seconded the motion, which passed unanimously.

#### Approve 2023-2024 School Calendar

Superintendent Waite presented two calendar options for consideration. The only difference between the two calendars is the make up of the inservice days. It was noted that the 2024 graduation date was not on the calendar. Mr. Mills stated that it looked like state track would be May 16 & 17 next year and he would propose that graduation be held on Wednesday, May 22<sup>nd</sup>. Concerns were expressed about a mid-week graduation date. It was determined that a graduation date would not be set at this time and input would be gathered from the senior parents. Discussion turned to enrichment day ideas. Some suggestions were; GO STEM, career exploration, college classes along with other ideas. It was noted that the enrichment days are the same on both calendars. Once the school day schedule is set, plans can move forward with enrichment days. Ken Patterson moved to approval of 2023-24 Calendar option #1. Joe Fisher seconded the motion, which was unanimously passed.
