Minutes of CONNEAUT BOARD OF EDUCATION REGULAR MEETING

April 26, 2021

The Regular Meeting of the Conneaut Area City Schools Board of Education was held on Wednesday, April 26, 2021 at the Conneaut High School 381 Mill Street, Conneaut, Ohio 44030. The Regular Meeting was preceded by a 9:57a.m. Work Session.

Members Present: Penny Armeni, Christopher Bartone, Suzanne Bernardini, Christopher Brecht, and Joan Norton.

Others Present: Keith Troia, Brian Haytcher, and Eric Hrin.

President Penny Armeni called the meeting to order at 10:31a.m.

Certifications by Treasurer that the Board of Education is in Compliance with meeting requirement rules.

Work Session: Mrs. Riley began the work session discussion regarding staffing changes for next year. After surveying staff for interest in open positions for next year, Mrs. Riley was able to accommodate existing staff prior to posting any remaining open positions. In planning to provide a smaller class size, she is planning for six classrooms for grades 3, 4 and 5 at Gateway Elementary and six classrooms for grade 2, 7 classrooms for grade 1 and 6 classrooms for kindergarten, with the anticipation of needing one additional classroom for kindergarten pending enrollment numbers. Mrs. Riley also anticipates about seventy students interested in participating in the online SOAR program. With smaller numbers for online learning, the Ashtabula ESC will operate the online program for most of the county schools. Mrs. Riley noted that she is planning for a five-day school week next year, pending any changes in guidance from state and local health officials.

Mrs. Riley also reported that the Conneaut Middle School boiler project has been installed and is pending final closeout on the project. The windmill has been take down and cleanup of the area is in process. On April 27, a COVID-19 clinic will be held for 16, 17 and 18, year old students. With many end of year school events planned, staff and students are encouraged to be vaccinated.

Dr. Timothy Neal, Conneaut High School Principal, provided the board with an update of change in high school graduation requirements effective for the Class of 2023 and beyond. There will be three steps for graduation which include 1) credits and curriculum – meeting the 23 credits required by board policy; 2) show competency on end of year exams with a passing or proficient level; 3) show readiness by earning two diploma seals from the ODE approved list that line up with goals and interests of students. To support the change in graduation rules, all students will have a written pathway plan beginning in the 2021-2022 school year.

Mrs. Miranda reviewed the OASOB Understanding School Funding webinar and shared with the board the Ohio Fair School Funding Plan (FSFP) is now included in HB110. The bill was passed by the House on 4/21/2021 as written. Simulations provide an estimation that if fully funded would provide \$177,291 for FY22 and \$16,598 in FY23 for the district. The House version rolls the Governor's Success and Wellness calculations into the foundation formula. Mrs. Miranda also shared that the fiscal office would be transitioning to new software after the May 7th payroll. The State of Ohio annual audit is complete for fiscal year 2020 with no findings for recovery or substantial finding. The district has received a list for consideration from the Ashtabula county Auditor, David Thomas, of seventeen properties within our district that have requested over \$50,000 of reduction in appraised value.
