ORDINANCE 3-1996

AN ORDINANCE VACATING THE ANNEXATION OF OVERLAND PARK ADDITION, AS SET FORTH IN ORDINANCE 2-1995, AND ANNEXING THE WILDHORSE RIDGE ADDITION TO THE TOWN OF FLEMING, COLORADO

THAT the annexation of the Wildhorse Ridge Addition, described as:

SEE EXHIBIT A, ATTACHED be and hereby is annexed to the Town of Fleming and made a part of said Town, and zoned "residential".

THAT in annexing said property to the Town of Fleming, the Town of Fleming does not assume any obligation respecting the construction of water mains, sewer lines, gas mains, electric service lines, streets or any other services or utilities in connection with the property hereby annexed.

Legal Description of the property to be annexed.

A parcel of land in the Southeast Quarter (SE1/4) of Section 4, Township 8 North, Range 49 West of the Sixth Principal Meridian, Logan County, Colorado, said parcel being more particularly described as follows:
