22-B-32 APPROVAL – TROPICAL STORM IDA AUTHORIZATION TO REMEDIATE DAMAGES

Whereas, the Englewood Public School District has suffered flood damage from Tropical Storm IDA at John Grieco Elementary School and the Winton White Stadium Complex. Governor Murphy has declared a state of emergency as per Executive Order 259, which allows for local governments the ability to utilize emergency procurement methods for goods and services to address the health, welfare and safety of staff and students for damages suffered from Tropical Storm IDA

Whereas, the Business Administrator has submitted a claim to the school district's insurance carrier for damage suffered at John Grieco Elementary School and the Winton White Stadium Complex. The insurance carrier will also provide district protocols to follow in order to remediate both sites. Once the district is informed of the protocols they must be executed upon receipt.

Whereas, President Joseph Biden has approved a disaster declaration for Bergen County, New Jersey. This declaration allows for federal funding for Tropical Storm IDA damages. Therefore, the Business Administrator has submitted a Preliminary Damage Assessment Form to the New Jersey State of Office of Emergency Management to report the estimated amount of Tropical Storm IDA damage in the amount of \$24.2 million dollars for the John Grieco Elementary School and the Winton White Stadium Area. This application includes all approximate estimates for site remediation/clean up, reconstruction/replacement of all areas, damaged supplies/equipment and flooding preventative measures. The Business Administrator has filed a FEMA project application to continue to qualify for Federal Aid for Tropical Storm IDA.

Therefore, be it resolved, upon the recommendation of the interim superintendent the EBOE authorizes the Interim Superintendent and Business Administrator to execute all necessary actions to remediate damages suffered by Tropical Storm IDA in order rebuild areas affected at John Grieco Elementary School and the Winton White Stadium Complex.
