

The regular meeting of the Pennsville Board of Education was called to order at 6:04 pm on Monday, July 24, 2017 by Mrs. Bodine.

MEETING CALLED
TO ORDER

Board members present were Messrs. Acton, Chambers, Hassler, Lang, Nugent, Thomas, Mrs. Phillips, Mrs. Staffieri-Morris and Mrs. Bodine. Also present were Mr. Davidson and Dr. Brodzik.


