SALEM COUNTY VOCATIONAL-TECHNICAL ACADEMY

The Board supports providing collaborative efforts in education. The Board has agreed to host an Academy for the Salem County Vocational-Technical School (SCVTS). Academies are highly focused programs for students with specific interest in a given specialization.

Academy programs are offered on a full time basis to students from various school districts in Salem County who qualify. Students who attend the Academy hosted by Pennsville Memorial High School (PMHS) are SCVTS students and receive dual diplomas from PMHS and SCVTS.

Transportation to and from the host district to the resident district is the resident district's responsibility.

In order to provide for a well-rounded program, GMT/Music Academy students are permitted to participate in co-curricular activities at PMHS rather than at their resident school. Co-curricular activities include but are not limited to club meetings, marching band, field trips, senior trip, music trip, dances, Hop and Prom. The Board will permit such participation as long as the student is enrolled full time in the GMT/Music Academy currently housed at PMHS. Students attending off-campus SCVTS Academies will have opportunities to participate in these types of co-curricular activities at their Academy full time host school. SCVTS students who attend programs off-campus will not be permitted to participate in co-curricular activities at Pennsville. Full-time SCVTS and off-campus academy students may only attend PMHS dances (Prom, Hop, Etc) as guests of PMHS students provided that the out of district guest protocols have been met.

The Academy program also can provide an opportunity for its students to participate in interscholastic athletic programs in their resident high school. Yet, there are times when this may not be feasible, such as making practice schedules and meeting the team bus for away games. Under such circumstances, the NJSIAA does allow for an application for a hardship waiver in order to permit the student to participate at the host district. The Board will require any student that wishes this waiver to receive both the written approval from both his/her resident high school principal and the Pennsville Memorial High school Building Principal prior to beginning the program. Off-campus full-time SCVTS students may only participate in Pennsville athletic programs when a similar program is not available through SCVTS.

On November 16 and 17, I was fortunate to be able to attend the New Jersey Association of School Librarians Fall Conference in Long Branch, New Jersey.

The conference opened with a presentation by Judy Freeman, a renowned expert on children's literature and former New Jersey librarian. I have never been able to get to Long Branch for this opening ceremony before because of the distance and rush hour traffic. It was wonderful to hear a leading authority on the importance of read-alouds.

DAY 1

Workshop 1: DIY Research Model

Four librarians, pre-K through 12, explained how they developed a research model for all grade levels to create consistency, continuity and buy-in for teaching and doing research. This has been a topic of discussion in our library department meetings.

Workshop 2: Thumbs up or down? Best books for young adults.

Two librarians gave plot summaries, reviews, and target audience for many novels released in the last year. I found a few books I want to add to my wishlist, and several titles I will share with Amy Baran.

Workshop 3: EBSCO Vendor workshop

This workshop highlighted best practices in using the EBSCO databases to which the high school subscribes and which I introduce to our students to start preparing them for high school.

Workshop 4: Beyond the book: How to experience literature through making part II

This librarian has students create many things using crafts, digital media, writing and drawing in her library class. I was impressed with some of her coding activities.

Workshop 4: Beyond the Book: How to Experience Literature through Making Part 2 w/ Maren Vitali The presenter offered various activities for integrating hands-on maker spaces with literature. Although this was skewed more to an elementary library class, there were some interesting ideas for projects and activities.

Engagement Reception

This session encouraged connecting with the local and state level organizations, universities, authors and vendors. It is always hard to squeeze in visiting the booths without missing a workshop session, so this was great. We actually solved a cataloguing issue with our book vendor and explored makerspace activities and suppliers.

DAY 2

Workshop 1: AASL Standards Refresh

The American Association of School Librarians has revised the National School Library Standards, focusing on competencies, not outcomes. This was the New Jersey premiere of the new standards and frameworks. The digital resources provided will require some serious time and attention.

Workshop 2: Making kids and authors your partners: Life -to-text-connections as a springboard for deeper literacy.

Jordan Sonnenblick, a well-respected author of books aimed middle grades and experienced educator, emphasized the importance of connecting texts to students' lives to increase engagement and deeper understandings. He provided multiple example activities and thematic units that he has used.

Luncheon Panel: Where are the LMCs in our Future Ready Schools?

A panel provided an update on the DOE's Future Ready Schools-NJ initiative and discussed the role of librarians in this initiative.

Workshop 3: Integrating research instruction and technology with subject teachers.

A librarian explained how he used a research model (he used the Big 6) to scaffold research instruction and to create short, student-centered activities which allowed him to facilitate rather than lecture.

Workshop 4: Augmented and Virtual Reality: The new frontier of learning.

Although I understand the potential of AR and VR in education, I was not familiar with the equipment such as Google Cardboard or the Homido VR headset, both of which work with Smartphones and were very reasonably priced.

My thanks to the Board of Education and Kyle Baker for allowing me to partake of this feast of professional development specific to school libraries, literacy, information literacy, and technology.
