ORDINANCE NO. 4-1996

AN ORDINANCE IN SUPPORT OF ORDINANCE #2-1934, BEING AN ORDINANCE PROVIDING FOR THE VACATION OF A PORTION OF SOUTH RAILWAY STREET IN THE TOWN OF FLEMING, COLORADO, AND IN SUPPORT OF ORDINANCE #2-1955, BEING AN ORDINANCE PROVIDING FOR THE VACATION OF A PORTION OF NORTH RAILWAY STREET IN THE TOWN OF FLEMING, COLORADO.

WHEREAS, Ordinance #2-1934, being an ordinance providing for a vacation of a portion of South Railway Street, lying north of Lot 25, Block 4, Dunn's Addition to the Town of Fleming, Colorado, was adopted and approved on October 3, 1934; however, the original copy of such ordinance was never signed by the Mayor; and

WHEREAS, Ordinance #2-1955, being an ordinance providing for the vacation of a portion of North Railway Street in the Town of Fleming, Colorado, was adopted and approved on November 7, 1955; however, the original copy of such ordinance was never signed by the Mayor or Town Clerk.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF FLEMING, COLORADO:

THAT Ordinance 2-1934, is hereby declared to be in full force and effect as of October 3, 1934, as follows:

That the portion of South Railway Street lying North of Lot Twenty-five (25), Block Four (4), Dunn's Addition to the Town of Fleming, Colorado, hereinafter more particularly described, be vacated, to-wit:

Beginning at the Northeast corner of Lot Twenty-five (25), Block Four (4), Dunn's Addition to the Town of Fleming, Colorado; thence in a Northwesterly direction and along the Northwesterly line of said Lot Twenty-five (25) to the Northwest corner of said Lot Twenty-five (25); thence due North and along the West line of said Lot Twenty-five (25) extended, a distance of fifteen (15) feet; thence in a Southeasterly direction and parallel with the North line of said Lot Twenty-five (25) to a point on the East line of said Lot Twenty-five (25) as extended, and thence due South a distance of Fifteen (15) feet to the Northeast corner of Lot Twenty-five (25), as the place of beginning.

THAT Ordinance 2-1955, is hereby declared to be in full force and effect as of November 7, 1955, as follows:

That the following described portion of North Railway Street located in the Town of Fleming, Colorado, be and the same hereby is vacated and closed, to-wit:

The North Twenty-five (25) feet of North Railway Street in the Town of Fleming, Colorado, located between the Eastern and Western boundary lines of Block Nine (9), Original Town of Fleming, Colorado, extended South.
