## ORDINANCE FOR ADOPTING THE BUDGET Ordinance # 5, 1974

An ordinance adopting the budget for the Town of Fleming, Colorado for the fiscal year BEGINNING ON THE 1st DAY OF JANUARY, 1975, AND ENDING ON THE LAST DAY OF DECEMBER, 1975 estimating the AMOUNT OF MONEY NECESSARY TO BE RAISED BY TAX LEVY BASED ON THE SAID BUDGET SO ADOPTED, ESTIMATING THE AMOUNT OF MONEY TO BE DERIVED FROM OTHER REVENUE SOURCES, AND SETTING FORTH THE TOTAL ESTIMATED EXPENDITURES FOR EACH FUND.

WHEREAS, The Finance Chairman designated to prepare the annuel budget for the Town of Fleming, Colorado for the fiscal year beginning January 1, 1975 and ending December 1, 1975

has prepared said budget and submitted it to the Town Council and,
WHEREAS, The Town Council held a public hearing on said budget on October 7th, 1974 and, whereas the assessed valuation of taxable property for the year 1975 in the Town of Fleming as returned by the County Assessor of Logan County, Colorado, is the sum \$455,300.00.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FLEMING, COLORADO That the estimated revenue and expenditures for the various funds of the Town of

Fleming age:

That the budget for the Town of Fleming, for the fiscal year beginning January 1 1975 and ending December 31, 1975, as heretofore submitted to the Town Council for the finance chairman, and as changed and amended by said Town Council be, and the same hereby is adopted and approved as the budget for the Town of Fleming for said fiscal year. That the budget herein approved and adopted shall be signed by the Mayor and Town Clerk and made a part of the public records of the Town.
