Title I Parent Involvement District Policy

It is the intent of the Grayson County Board of Education that parents of participating students shall be provided with frequent and convenient opportunities for full and on-going participation in the Title I Program, including opportunities to suggest modifications, based on changing needs of parents, students, and schools.

<u>Lawler Elementary:</u> <u>Title I Parent Involvement Policy</u>

<u>Purpose:</u> The Parent Involvement Policy ensures equitable participation in the planning, reviewing and implementing of all parent programs and activities.

Procedures: Lawler Elementary, along with the district Federal Programs Coordinator, shall convene an annual meeting to coincide with the first PTO meeting of the school year, to which all parents are invited and encouraged to attend.
