Dear parents and Guardians:

In accordance with the Every Student Succeeds Act (ESSA)/PARENTS' RIGHT-TO-KNOW, this is a notification from Valliant Public Schools to every parent of a student in a Title I school that you have a right to request and receive in a timely manner:

- a) Information regarding the professional qualifications of your student's classroom teachers. The information regarding the professional qualifications of your student's classroom teachers shall include the following:
  - If the teacher has met state qualification and licensing criteria for the grade level and subject areas taught;
  - If the teacher is teaching under emergency or temporary status in which the state qualifications and licensing criteria are waived;
  - The teachers baccalaureate degree major, graduation certification, and field of discipline; and
  - Whether the student is provided services by paraprofessionals, and if so, their qualifications [ESSA 112(e)(1)(A)(i)-(ii)]
- b) Information regarding any state or local educational agency policy regarding student participation in any assessments mandated by ESSA) and by the state or local educational agency, which shall include a policy, procedure, or parental right to opt the child out of such assessment, where applicable. [ESSA112(e)(2)9A]]
- c) In addition to the above information you will be notified if your student has been taught for four or more consecutive weeks by a teacher who does not meet the applicable state certification for licensure requirements at the grad level and subject area in which the teacher has been assigned. [ESSA 112(e)(1)(B)(ii)]
