

First and foremost, thank you. Families and community, we appreciate you and your continued partnership with our school as we support our students in coming back to in person learning and schooling. The COVID19 pandemic has created some unusual challenges to navigate and yet we continue to lift the sky together and do our best for our kids. It is appreciated.

With the pandemic still in full force, just a friendly reminder that we do still need to adhere to masking expectations when on campus for the safety of our students, staff, and families. Overall this has been going well and we are grateful for that. On a similar note, we are hopeful that we will soon get permission for possible volunteers or events with safety protocols in place on campus. Currently, we are erring on the side of caution and are not yet as a district having volunteers in buildings or large events aside from very rare or unique circumstances and with special permissions. Schools that have free/reduced lunch percentage at or above the district average qualify for additional funding through a Title 1 federal grant.


Mark your Calendars! Fall Conferences!
