#### **PUBLIC COMMENT**

Karen Herald of Waynesboro, expressed concern about the declining test scores and what has changed over the past years they may have resulted in the decline.

## PRESENTATION - ELEMENTARY SCHOOL PERFORMANCE PROFILE

Elementary principals presented the 2014 PSSA results, noting highlights and explaining their focus for increasing student achievement.

## Highlights include:

- Fairview had increased reading scores in all grade levels.
- Fairview had three advanced scores in 5<sup>th</sup> grade writing.
- Hooverville's 6<sup>th</sup> grade cohort showed dramatic score increases Reading 71% to 83% and Math 81% to 94.4%.

- Hooverville had increased reading scores in grades 4, 5 & 6.
- Mowrey 6<sup>th</sup> grade math scores increased from 69% to 81%.
- Mowrey 4<sup>th</sup> grade received 93% Proficient/Advanced in Science.
- Mowrey 4<sup>th</sup> grade math scores increased from 75% to 83%.
- Summitview 5<sup>th</sup> grade scored 90% Proficient/Advanced in math.
- Summitview 6<sup>th</sup> grade reading performance increased as a result of ELA content specific instruction.

- WASD English Language Arts Modules
- Common benchmark assessments in reading and math
