I further certify voting will be at large in both the primary and general elections pursuant to "Voting Plan A" as defined in K.S.A. 25-2005.

BOARD MEMBER POSITION NO. 4 (presently held by David Hand) to be elected from Board Member District No. 1.

BOARD MEMBER DISTRICT NO. 1 is described as follows:

- 1. All of Sections One (1) through Eighteen (18) inclusive and Section Twenty-nine (29) in Ellsworth Township, Ellsworth County, Kansas **NOT** incorporated in the City Limits of the City of Ellsworth, Kansas.
- 2. That area of the City of Ellsworth lying North of the South right-of-way of West Old Highway 40 and West Kansas Highway 14.
- 3. That area of the City of Ellsworth which is located West and South of West Old Highway 40 and it intersection with the center line of N. Grand Avenue extended, in the City of Ellsworth as the point of beginning; and from said point of beginning running southerly down the center line of North Grand Avenue to the middle of the intersection of 8th Street and North Grand Avenue and thence Southerly down the center line of North Grand Avenue to its intersection with East Main Street and thence easterly down the center line of East Main Street to the Center Line of Douglas Ave/Kansas Highway 14, thence south down the center line of Douglas Avenue/Kansas Highway 14 where they border or parallel the City limits of Ellsworth on the West and continuing South along the City Limits to the very South end thereof.

BOARD MEMBER POSITION NO. 3 (presently held by Peggy Svaty) and **BOARD MEMBER POSITION NO. 6** (presently held by Elizabeth Donley) to be elected from Board Member District No. 3.

- 2. The entire City of Geneseo, Rice County, Kansas; and
- 3. All of Blackwolf, Sherman, Garfield, Clear Creek and West Empire Townships in Ellsworth County, and
- 4. All of Sections 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 30, 31, 32, 33, 34, 35 and 36 in Ellsworth Township, Ellsworth County, Kansas, **NOT** incorporated in the City Limits of the City of Ellsworth, Kansas.
- 5. The portion of Carneiro, Columbia, Noble, Lincoln, East Empire, Langley, Mulberry, Trivoli, Thomas, and Ash Creek Townships, Ellsworth County, Kansas located within the boundaries of U.S.D. No. 327 (Ellsworth-Kanopolis-Geneseo); and
- 6. The portion of Victoria and Galt Townships of Rice County, Kansas, located within the boundaries of U.S.D. No. 327 (Ellsworth-Kanopolis-Geneseo); and

Said Board Member District No. 3 being otherwise described as all the area of Unified School District No. 327 Ellsworth County, State of Kansas (Ellsworth-Kanopolis-Geneseo) not specifically described as being in Board Member District No. 1 or No. 2.

There are no positions being filled from Board Member District No. 2 or from Board Member District At-Large for this election

BOARD MEMBER DISTRICT NO. 2 is described as follows:

1. All the City of Ellsworth **EXCEPT** that area of the City of Ellsworth contained in Board Member District No. 1.
