## 10. Board of Education - Action Items

Action: A. Approval of Proposed 2019-20 School Budget

Assistant Superintendent for Business and Operations, Dr. Bruce Capron presented the Proposed 2019-20 School Budget

- Appropriations and revenue are balanced in the budget proposals this evening
- Tax cap limit and use of operating reserves were highlighted

Dr. Capron highlighted incremental revenue shifts since 2015-16 moving forward to 2019-20.

Q - 2017-18 - There was a lower CPI this year

Superintendent Mancuso detailed the trends in upstate NY and how this impacts the budget overall.

Dr. Capron highlighted the initial gaps that were realized after aid figures were released from the state and recommendations were heard from the buildings and PBAC. There was also feedback during the board's budget workshop last Tuesday, April 2, where priorities were set even further.

Dr. Capron clarified the budget strategies leading to the balancing of the budget and recommendations being brought forward to the board this evening.

All slides will be duly maintained in the BoardDocs packet, should the Board of Education approve the draft budget presented to them this evening.

Voter propositions were placed in front of the Board for final consideration.

The board thanked the administration for their diligent work, realizing that reductions are never easy. Superintendent Mancuso echoed that enrollment is down the last ten years by 460 students and some teacher shifts have also occurred. As always, the District seeks to maximize its state aid and understand if the staff to student ratio is where it should be.

The school bus proposition was also highlighted before action was taken. This is in line with the long-range purchase plan, which will be a mix of large and small buses. It was clarified that the dollar figure is also embedded in the overall budget figures, however it needs to be voted on separately due to financing options that need to be made

available to the District, if needed. It was clarified that it is not the intent of the District to borrow funds for financing, but authorization must be sought to borrow, if needed.

Discussion, Information: C. Solar Tax Exemption Request

Ambulance facility on Rts 5 & 20.

Details are highlighted in the background statement.

Solar tax exemptions were approved by the HF-L Board of Education last year, to be reviewed on a case by case basis. If the board is interested, the attorney will draft a PILOT agreement between the two municipalities. With the ambulance, fire department and other sharing partnership opportunities, this is something the Village of Lima is requesting.

The school's attorney would draft a PILOT agreement to exempt the solar equipment and maintain the exemption on the land. The board was in agreement to proceed with drafting an agreement. Action will be requested at a future meeting.
