- 2. The school district is closed for students from March 16,2020 until further notice The board notes that March 16, 2020 is the final remaining SNOW DAY in the school calendar. Other closure days are pursuant to County Executive and Department of Health directive to close school as a result of the COVID-19 virus. Depending on the length of school closure, the board of education may be required to amend the school calendar to eliminate the Memorial Day Holiday and other school vacation days.
- 3. The board of education meetings from this date forward until further notice shall be closed to the public under Governor Executive Order 202.1. The school district shall make the meeting accessible to public participation through video streaming or
