Discussion, Information: A. Announcements

Food Services Director, Dana Boldt will be hosting an event for her staff for their commitment and support during these challenging months of the school closure while continuing to serve the community. Participation has decreased, which is beleived to be a good sign that the economy may be improving and people are getting back to work.

Assistant Superintendent for Curriculum and Instruction, Dr. Renee Williams spoke about the recent staff development session with a large number of staff on a virtual platform. She expressed that this was believed to be a once in a lifetime opportunity to present to such a large number of staff and administrators at one time, by a world-renowned educator.

Board President, Carol Bellavia attended the keynote and found Mr. Mattos to be a very engaging speaker. Staff asked some good questions. Kudos to those who were able to secure this event.

Superintendent Mancuso reported that virtual graduations were a huge hit. Parents have expressed deep gratitude and thanks, and would like to repeat the process again in the future. Mr. Mancuso extended his appreciation for the incredible job by the high school staff. High school guidance counselors also did an outstanding job with awards, and the athletic awards were also very well-received. Athletic Director, Brian Donohue will speak about this further during his report this evening.

Director of Pupil Personnel Services, Lindsay Ali spoke about a great deal of collaboration both in-house and regionally to support the well-being of students and others.

Mr. Mancuso reported that the first session of the Re-Opening Task Force was well attended this evening with meaningful input with the majority of attendees in agreement with hoping to get the kids back to school and engaged, in whatever format that might be.
