Oologah-Talala Upper Elementary will send frequent reports to parents concerning their child's progress. The Title 1 staff will facilitate family night reading activities and provide training to parents during the Title 1 Information meeting. Flyers will be sent home and remind messages will be sent prior to the events. Agendas and attendance records will be kept by the Upper Elementary Reading Specialist for each event. The Title 1 Reading Specialist and/or classroom teachers will also make an appointment (at any parent's request) to demonstrate or share activities to use at home. Parents will also complete a survey/questionnaire once a year for title committee to review. These documents will be reviewed and changes will be made based on the results. Parents will serve on the Title 1 Site Committee and are strongly encouraged to provide input regarding the program and additional methods to increase parent involvement. Oologah-Talala Public School teachers communicate through phone calls, Remind messages, parent-teacher evening conferent voice a year, newsletters, flyers, Mustang Mike phone calls, and social media including Facebook and Twitter. All parents are contacted frequently if a child is not making adequate progress in Reading. All communication is kept in teacher communication logs. If necessary the students' behavior and/or academic reports can be sent home for weekly updates. Parents will receive progress reports, report cards, and assessment reports throughout the year at the end of each quarter. Parents are updated to their child's progress to support our goal of Student Growth. They also can access Wengage parent portal for current grade information. Information is also available on Oologah-Talala Public Schools website with a parent tab with access to information and academic standards. All communication is thoroughly reviewed by the Title 1 Reading Specialist and Building Principal for east of understanding and accuracy posted on the school and classroom websites.

The Upper Elementary Schoolwide Committee which includes teachers, the Reading Specialist, The school Principal, Administrators, parents, and other appropriate school personnel develop and review annually the Upper Elementary Title Plan The updates are made according to the current needs of students based on OSTP data, NWEA data, and teacher data. The Principal and Reading Specialist are responsible for relaying information about the implementation of any new program with the school setting, as well as reporting on progress and test results. Parents of all children are asked to provide feedback regarding their view of the program's effectiveness based on their person experiences. The Assistant Superintendent and/or the Superintendent are available to oversee the committee meetings and provide guidance to ensure that the actions of the committee are in compliance with Title 1 regulations. The plan is shared with the entire staff of the Title 1 school during school faculty meetings help in the spring and directed by the school Principal. Input from the staff is encouraged, noted, and brought back to committee for further discussion. Information is shared with parents of the community at the beginning of each school year during a Title 1 information meeting and during pre-planned Open House activities led by classroom teachers, the Building Principal, and Reading Specialist. According to the 2019-2020 school year data the Upper Elementary shows a strength in vocabulary . The weaknesses are for Language and the Reading/Writing Process. With this data teachers will adjust their teaching and their goal for the 2021-2022 school year. Some of the ideas teachers will be implementing will include focusing on language specific activities when appropriate, and working together to come up with a enhanced plan to improve writing across all grade levels. This will begin with the grade level and then we will work as a team to vertically align 3rd-5th grade students. Teachers will evaluate through progress monitoring mid year to assess the progress and make adjustments.

Highly qualified Reading Specialist and highly qualified paraprofessionals will work with students daily in small groups using proven research-based strategies encompassed within:

- Pearson Reading Series
- One-on-one Tutoring sessions offered to any student that shows a need
- Guided Reading small-group sessions, focusing on comprehension and vocabulary development
- Literacy First word-working activities to build word decoding skills and sight word vocabulary
- Accelerated Reader to develop prosody and comprehension

Students will receive additional instruction during reading intervention time. The program incorporates additional instruction of the existing vocabulary, story elements, and reading strategies that are focused on weekly in the classroom by conferencing and planning regularly with classroom teachers. The Reading Specialist and highly qualified paraprofessional will pull from the classroom and work with small groups to work on specific skill building activities. After school tutoring will be offered throughout the year and as funds are available. Summer school will be offered to students who qualify and as funds are available. Schoolwide reform strategies include all students, and are designed to determine a students impending and instructional reading level, and then activities are provide to accelerate progress based on individual needs and abilities. Accelerated Reading is used as an incentive program that all students are strongly encourage to participate in to help develop long term reading comprehension, vocabulary, fluency and appreciation of literature. In addition to these year long programs Literacy skill lessons and activities are taught daily in all classrooms to help all students increase their foundation reading skills. During the 2021-2022 school year the Upper Elementary Committee has determined that their is a need to strengthen our EL and above average students. They will be working together in grade level and building level PLC's to meet this goal.

Professional Development

The district Professional Development Committee which consists of teachers, administrators, and parents has designed a professional development plan that addresses the districts professional development goals. Each teacher will have a Professional Learning Focus in which they can see out specific Professional development to achieve their focus goal. Title 1 funds may be used to send teacher to various professional development opportunities such as Literacy First and/or Title 1 conferences. The Upper Elementary Site Committee will determine the professional development needs of their site by surveys each year sent out to teachers. The surveys are also given after the professional development opportunity for follow-up and future planning. Opportunities for professional development outside the district is available for classroom teachers, Title 1 teachers, and administrators, The district will provide the training on site to meet NCLB requirements at the beginning of each school year. Attendance records are kept by the building secretary of this training. Any training that parent participation is appropriate training will be advertised as being open to parents. The Title 1 staff and classroom teachers will work together for schoolwide professional development. This provides a shared knowledge base of procedures and instructional models, and allows for better communication regarding content of instruction, procedures, and expectations.

Prevention and Intervention Strategies for Low Achieving Students

Oologah-Talala Upper Elementary school uses a variety of intervention strategies to help students succeed. Classroom teachers will monitor and evaluate low-achieving students receiving interventions weekly to adjust the intervention plan as necessary.

All intervention plans are based on the Oklahoma Academic Standards as the educational goal. Some of strategies are:

- -Response to Intervention will include collaboration of teachers and reading specialists data is analyzed to create small reading skills groups to increase student achievement
- Accelerated Reader goals are established for each student and teachers will assist with tracking and monitoring
- After school tutoring and Summer school will be provided to any student that needs additional support
- Differentiated Instruction according to students' math and reading skills all students are grouped to offered differentiated instruction

Teacher Participation in making assessment decisions

To ensure teachers are involved in decision making each grade level meets once a week as a team to discuss issues with curriculum, testing, and various assessments. Oologah-Talala Upper Elementary school has aligned its curriculum from third through fifth grade. Teachers also work with lower elementary to ensure students needs are being addressed. This ensures that each grade level is working on skills and instruction consistently to raise all students level of achievement,. Teachers meet in vertical planning sessions annually to have curriculum discussions, and to review testing and evaluation results. Grade level teams then create a mapping calendar to guide instruction for the school year. Teachers review assessment forms and create focus lessons and groups to meet the needs of all students. Specific plans are tentatively made for most subgroups at this time. Academic goals are prioritized and instruction and intervention strategies are utilized to achieve these goals. New students are assessed within the first week of the attending school. These students will be discussed to make decisions on what skills they need or may be lacking when they arrive.

Oologah-Talala Public Schools speech administrators and Title 1 Reading Specialists meet with the Title, JOM, and Special Education teachers on an as-needed basis to share relevant information about the services, materials, ad best practices used to teach qualifying students, as well as the results of the OSTP, focusing on sub areas in order to analyze needs and develop a plan of improvement. The Title 1 District Schoolwide Committee and Title 1 Site committee will meet in May of each year to review the effectiveness of the program based on parent input, progress reports from classroom teachers and reading specialists, and recent assessment results from the NWEA, DAR, and/or Literacy First. Overall program results will be discussed and analyzed so that changes needed to increase efficacy may be written into the Title 1 District Plan for the upcoming year. In addition classroom teachers pre and posttest their students to determine growth and identify areas of concern. The following assessments may be utilized:
