## La Villa ISD COVID-19 Stages



**Stage 1:** Standard operational procedures with intensified sanitizing protocols; all students and staff report to school.

**Stage 2:** Parent Choice School Attendance Plan (PCSAP): All staff report to work. Parents have the choice to send children to school or keep them at home without penalty.

**Stage 3:** All teachers and all students stay at home. Employees work from home, except for some essential employees who can report to District buildings.

**Stage 4:** All students and all staff stay home.

## Two Options for Remote Instruction



#### Method A

- Synchronous Instruction Requires all participants to be present at the same time, virtually
- <u>Examples:</u> Live interactive classes with students & teachers participating realtime, teacher supported work time on video conference calls, scheduled and timed online tests

#### **Method B**

- Asynchronous Instruction -Does not require all participants to be virtually present at the same time
- Examples: Self-paced online courses with intermittent teacher instruction, preassigned work with formative assessments on paper or in LMS, watching pre-recorded videos of instruction with guided support



Both instructional delivery formats must cover the required curriculum per TEC, §28.002

# Distance Learning: Synchronous & Asynchronous Instruction Defined







- Synchronous Instruction will be provided in live, real-time through a Chromebook or electronic device.
- Asynchronous Instruction will be available daily through Selfpaced online courses (Pre-recorded lessons & live check-ins)
- Teachers will provide instruction, learning resources, and support using Google Classroom.
- The Learning Management System (LMS) teachers will utilize will be google classroom for Pk-12 grade student work.
- District will ensure open lines of communication among teachers, students, and parents to ensure each student is academically and socially-emotionally ready.

# Synchronous Instruction Expectations (Live instruction at home)



- Requires ALL participants to be present at the same time, "Virtually", as per their daily class schedule provided.
- Students are ready to engage and learn.
- Students should have a designated, distraction-free workspace to engage in learning platform-(Zoom/Google/Seesaw)
- Students will participate in the class activities, discussions, and assignments --(LMS)
- Attendance will be marked the same as on campus along



# Asynchronous Instruction (Pre-recorded Instruction-Self-Paced)





- Does NOT require all participants to be virtually present at the same time.
- Self-paced on-line work with intermittent teacher instruction. (Pre-assigned work, assigned work on LMS, watching pre-recorded lessons with guided support and formative lessons.
- Students will show proof of participation by work submission (LMS-Google Classroom)
- Attendance is determined by student's documented daily instructional engagement.



## **Distance Learning Instruction**



- LVISD will implement Distance Learning protocols starting August 24, 2020 as per Hidalgo Health Dept. guidelines & Texas Education Agency transitional guidelines.
- Both remote and in-school experiences will maintain traditional grading practices and daily schedules.
- All courses will be offered in both settings, including advanced level courses.
- Attendance will be is based on daily engagement.
- There will be a consistent delivery of online instruction through Zoom/Google Classroom suite options.
- All teachers, grades PK-12, will utilize Google Classroom as their primary Learning Management System (LMS).

### Distance Learning:

LVISD will implement Distance Learning starting Aug 24, 2020 during that time we are going to serve curbside meals to students. Following TDA program regulations. (Transportation Delivery Assistance)

### Food Services Breakfast and Lunch (Return to school plan)

Based on building capacity and student enrollment, campus administration will determine areas that may be utilized for meals. These areas could include cafeteria, classrooms, the library, or other large areas within the school building.

# Call to School

## Modes of Learning Defined

- Face to Face Instruction with safety precautions
  - Traditional Instruction in the school building
- Remote <u>Synchronous</u> Instruction
  - At home learning
  - Real-time, live instruction and interaction between teachers and students
  - Students are required to attend class at scheduled times
- Remote <u>Asynchronous</u> Instruction
  - At home learning
  - Instruction is not real-time and is delivered through pre-recorded videos and lessons
  - Students are required to engage in each class daily by completing assigned tasks within the instructional day

## Return to School Option:1-Synchronous & Asynchronous Learning

## **In-Person Instruction**



#### **OPTION 2:**



- Teachers will utilize the same curriculum as distance learning.
- Students will attend class in-person, five days a week, with additional safety measures in alignment with state and federal guidelines and recommendations.
- Teachers will provide face-to-face instruction, learning resources and support utilizing Google Classroom.
- \* Staff and ESC1 working on revising curriculum that will quickly transfer from face-to-face to remote in the event of a temporary school closure due to COVID-19 spread.
- Attendance is marked based on student's present on campus.

## **School Operation Changes for In-Person**



#### **Beginning the school Day:**

- Submit health questionnaire through google form or hard copy (Beginning of Week).
- Temperature checks will be given curbside daily before entry to the building.
- Hand sanitizer stations will be available throughout the campuses and designated entrances
- Face coverings will be required to be worn by all staff and students with limited exceptions.
- Students or adults who exhibit fever or other COVID-19 related symptoms will be sent home until cleared to return to campus (Medical Release)

#### **During the school day:**

- Classrooms, learning spaces, and offices will be limited to smaller groups as recommended by CDC and TEA guidelines. Traditional rows and designated seating assignments will be implemented for campuses.
- Sanitizing and cleaning procedures will be increased at all La Villa ISD facilities.
- Regular handwashing procedures will be established at each campus.

- Multiple Entrances-Elementary/Secondary Students

#### **Afternoon Procedures**

- Student Lunch Delivery's to Designated Area (Café., Library, or Class)
- Bus Transportation-Student Escorted to bus upon bus # announcement
- Pick-Up-Student escorted to car upon intercom student name announement

#### **Transitions**

- Hallways Visible Social Distancing Marks
- Staggered Release of Students
- Restrooms & Water Breaks
- Fine Arts/Athletic Sponsors Draft Safety Plan/Outdoor Groupings
- Water Bottles will be allowed for students to avoid large gatherings.
