Later in this meeting Mr. James will present the contract with Bond Architects. Athletics is finishing up hiring all our new coaches, and it's been fun to watch them get long overdue supplies and materials. Few changes for MS Athletics are MS Volleyball will now be in the fall and we are also talking about adding 6th grade basketball for girls and boys in the near future now that the 6th grade is in the MS.

Cliff Wilson presented the Maintenance report-productivity is going very well! The HS, MS and Ag Building are fully painted and floors waxed. We are now working in the Elementary and moving right along with getting three classrooms and half hallway done in one day. Chain link fence bids- We have one bid right now waiting on a few more to get back to me so we can find the best option for the fence around the track. All equipment is up and working great!! We are still working on summer projects but our number one project is to get all the painting completed. We want the students and staff to come back into a fresh looking school.

Sharlet Peterson presented the summer school report- We had 360 students to start summer school and ended with 343 students. 231 students received incentive cards for having great attendance. Amounts received were \$100, \$75, \$50. You could only miss 14 hours total to still be able to receive incentive cards. Lots of learning went on this summer in all grade levels! Kindergarten was busy learning their ABC's, 4th grade did an Owl Pellet project. We brought in a speaker from Missouri Conservation the kids really enjoyed. We also brought in

children's book writer who read her book to the younger kiddo and then talked about the process of writing a book with our MS kiddos. In all it was a great summer and she very much appreciated the opportunity to run the program.
