D. Cleaning and maintaining healthy facilities, including improving ventilation: The district implemented air purification systems with the most effective environmental technology. EnviroKlenz devices have been situated in every learning and common space to effectively clean the air of viruses, bacteria, debris, and mold with UV lights and MERV 15 HEPA Filtration. Daily Surface Disinfection of the following: Door handles, toilet fixture handles, light switches, elevator buttons, student desks. cafe tables, exercise equipment, phones, keyboards.
E. Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments: Contract tracing is no longer required under Executive Order #242.
F. Diagnostic and screening testing: Diagnostic screening and testing is no longer required under Executive Order #242.

Efforts to provide vaccinations to educators, other staff, and students, if eligible: The district provided on-site Moderna vaccination clinics for Board employees and contracted staff on April 8, 2021 and May 6, 2021. The district provided on-site Pfizer vaccination clinics for students age 12 and up on June 2, 2021 and June 23, 2021.

Appropriate accommodations for children with disabilities with respect to the health and safety policies: The IEP team provides appropriate accommodations for students identified as needing special education and/or related services. The district will continue to monitor progress in each students' goals and objectives in the 22-23 school year and continue to make accommodations if and when necessary. All classrooms have been equipped with necessary PPE to ensure the health and safety of staff and students in order to deliver necessary accommodations and related services.

## 2. Ensuring Continuity of Services

(1000 character limit): The district has provided professional development to staff and parents on various relevant topics including data-based decision-making and accelerated learning. The district has implemented a data integration specialist initiative at each level to ensure teachers have access to high quality assessment information on an ongoing basis. The district hired a Mental Health Coach to facilitate trainings for staff and parents. The district's mental health coach provides staff with strategies for their own mental health as well as the mental health of their students. The district has developed a long-range SEL Platform for PD, SEL, Diversity, and Inclusion. The district has expanded our MTSS framework to enhance behavioral/SEL supports. The district has implemented after school and summer programs for targeted populations in grades K-12.

The district continues to work with stakeholders through committee meetings (administrators, parent groups, and school community members). The district surveyed staff and parents every 60 days for the 21-22 school year to obtain updated information and feedback. The district will continue to obtain parent input in the 22-23 school year.

The district uses Talking Points language translating software as a two-way multilingual family engagement platform helping teachers and families to stay connected via text message/email. Documents are translated in-house with interpreting services from staff members when necessary. Additionally, interpreters are provided during meetings to assure parent understanding of information being shared. ADA supports: the district plans to utilize Microsoft speech to text to include audio narration. The district will also provide options to have the plan printed and mailed when requested.
