### THE FACTS OF THE UPCOMING RENEWAL LEVY

The Shawnee Local School District is pursuing the renewal of an emergency operating levy in the upcoming election on November 2, 2021. Here are the key points of the renewal levy:



## SUPPORTS VITAL SERVICES





First passed in the 1990s, this emergency levy helps fund day-to-day operational expenses such as utilities, bus fuel, and classroom supplies. **We don't want these vital services to go away!** Passage of the levy will provide Shawnee Local Schools with \$2,880,000 per year to maintain these current expenses and continue providing for the students and staff of our district. An emergency levy is a "fixed sum" which means it will not increase the tax bill as the appraisal on your home or business increases; it is a fixed dollar amount. We are only asking for what is needed.

Proposed Tax Levy (Renewal) Shawnee Local School District Allen and Auglaize Counties

A majority affirmative vote is necessary for passage.

Shall a levy renewing an existing levy be imposed by the Shawnee Local School District for the purpose of

## providing for the emergency requirements of the school district

in the sum of \$2,880,000 and a levy of taxes to be made outside of the ten-mill limitation estimated by the county auditor to average 5.997 mills for each one dollar of valuation, which amounts to \$0.5997 for each one hundred dollars of valuation, for 10 years, commencing in 2022, first due in calendar year 2023.

- The levy will generate \$2,880,00 per year over the next 10 years for our district.
- The levy is for a 5.99-mill property tax.
- The vote is for the RENEWAL of the emergency levy, meaning...

### taxes will not be raised

as a result of the levy passing. Passage of the levy means the continuation of the already existing taxes.

• Taxes are fixed, meaning they will not increase as home valuation increases.

## IN PERSON AT THE ALLEN CO. BOARD OF ELECTIONS

## ABSENTEE BY MAIL WITH A PAPER BALLOT

The Allen County Board of Elections will mail your ballot to your home if you complete an absentee request application. Download and complete an **ABSENTEE BALLOT** 

**APPLICATION** (www.allen.boe.ohio.gov/absentee-voting). Mail the application to the Board of Elections.

Thirty days prior to the Election (around October 5th), your OFFICIAL BALLOT will be mailed to your address. Complete the ballot and return it to the Board of Elections either by mail or at the secure dropbox.
