# LUMPKIN COUNTY BOARD OF EDUCATION REGULAR SESSION MINUTES SEPTEMBER 13, 2021 7:00 P.M.

The Lumpkin County Board of Education met Monday September 13, 2021 at 7:00 p.m. at the Board of Education meeting room, located at 56 Indian Drive.

#### **Members Present:**

Chairman Bobby Self, Vice Chair Jim McClure, Mera Turner, Lynn Sylvester, Craig Poore and Superintendent Dr. Rob Brown.

After a brief welcome Chairman Self called the meeting to order. Superintendent Brown gave the invocation followed by the Pledge of Allegiance.

Chairman Self reviewed the agenda and called for a motion to adopt. On a motion by Mr. McClure and a second by Ms. Sylvester the agenda was adopted. Motion carried.

Superintendent Brown reviewed the August Board minutes. On a motion by Ms. Turner and a second by Mr. Poore the minutes were approved. Motion carried.

# **Testing Scores**

Director of Curriculum, Instruction, and Assessment, Mrs. Jennifer Moss, presented data from the most recent administration of Georgia Milestones in Lumpkin County. To preface her presentation, Mrs. Moss reminded the BOE that the Georgia Department of Education applied for a waiver in both July 2020 and again in February 2021 to waive high-stakes testing for Georgia students due to the COVID-19 pandemic. Both waiver applications from GaDOE to the US Department of Education were denied. Therefore, Georgia officials implemented guidance for the administration of the Georgia Milestones last year to include an extended administration window, changed the weight of EOCs from 20.00% to 0.01%, a suggestion that virtual students should not come into buildings for the sole purpose of testing if they feel uncomfortable, and most importantly, that the test results from the 2020-2021 school year cannot be used to make school-and-district level year-to-year comparisons because of the extenuating circumstances. Even with these flexibilities and disclaimers, Mrs. Moss presented data on Lumpkin County's performance in all areas compared to both Pioneer RESA and the state of Georgia.

For the Georgia Milestones End-of-Grade Assessment, Lumpkin County was above the Pioneer RESA average and the state average in every grade level and subject area except for 5<sup>th</sup> Grade Mathematics. For Georgia Milestones End-of-Course Assessments, Lumpkin County was above the Pioneer RESA average and the state average in every EOC course except for 8<sup>th</sup> Grade Physical Science.

#### **Strategic Goal Area: Parent and Community Engagement**

#### **Partner in Education**

Director of Community Engagement, Jason Lemley, presented the September 2021 Partner in Education Award to Family Care Dahlonega. Three years ago, when Lindsay and Jeff Dowis were new to town, they

set up a meeting with Dr. Brown and our administrators in December 2018 to introduce themselves and to start a partnership with our district. Over the past couple years, Family Care Dahlonega has continued to be a partner to our school district, our families, and our community. In addition to their healthcare services provide to our community through primary care, urgent care, and COVID testing, Family Care Dahlonega signed on as an in-kind sponsor for our annual REACH 5K with Dr. Lindsay Dowis personally attending and offering first aid care during the event last year. Most recently, Dr. Dowis reached out to LCSS in hopes of sponsoring and partnering in a recycling effort in our schools. Expanding on the plastic bottle recycling program already active at LCHS with the Environmental Awareness Club, Family Care Dahlonega contributed the funds to build 15 additional recycling bins. Those recycling bins are currently being constructed by our LCMS AgEd students, with 8 being placed on the LCMS campus, 4 additional bins for LCHS, and 1 bin for each of the elementary cafeterias. Thank you, Family Care Dahlonega and Drs. Dowis and Dowis, for your dedication to the Lumpkin County School District. We appreciate your partnership, and we look forward to working with you for many years to come.

#### **2021 Yale Educator Award**

Principal of Lumpkin County High School, Mr. Billy Kirk, recognized two members of the LCHS faculty as recipients of the 2021 Yale Educator Award. Mr. Alan Hogan and Mr. Johnathan Mullins were recognized by the Yale University Office of Undergraduate Admissions as a recipient of the award. With 305 nominees representing 38 states and 17 countries, only 50 teachers and 21 counselors were selected for this award. We are incredibly proud of Mr. Hogan and Mr. Mullins for being two of those educators.

## Strategic Goal Area: Operational & Organizational Excellence

#### **Financial Reports:**

Chief Financial Officer, Mr. Shannon Christian, presented the most recent financial reports for Lumpkin County Schools. ESPLOST reports included a collection of \$439,121.78 for August, 2021. Mr. Christian also presented the General Fund Financial Statement for year ending June 2021. With 100% of the fiscal year complete, we collected 100% of anticipated revenues and spent 100% of anticipated expenditures, leaving LCSS with a balanced year end.

Mr. Christian also presented an FY22 budge update:

With 8% of the fiscal year complete, we are at a point where revenues are not coming in at this time.

Mr. Christian updated the Board of Education on the advertised RFP to local financial institutions for the purpose of a Tax Anticipation Note (TAN). Mr. Christian presented the Resolution Authorizing the Issuance and Sale of a Tax Anticipation Note in the amount of \$3,000,000.00 at 1.38% (Truist Bank) and asked for Board approval.
