#### Meals

Breakfast will be grab and go and students will eat in their classroom.

There will be four lunch periods throughout the day. Students will be assigned seats at the lunch table.

#### **Restorative Practices**

#### I. RELATIONSHIP BUILDING & RESTORATIVE PRACTICES

Practices used consistently to build relationships and to proactively support ALL students:

- Each student and staff member is personally greeted with eye contact, a smile, and warm hello upon entering the school, classroom, hallway, elevator, and any location within the building.
- Each child is a student of every staff member. Staff members will be responsible for building a rapport with the students.
- Each student will learn about their classmates' differences and similarities & build a team bond throughout the school year via quarterly classroom exercises.
- Each new student & staff member will be welcomed by staff & students and will be assigned a buddy student or staff member
- Staff members will contact parents with a calm approach...positive/strength...concern...goal to help students grow.
- Students will engage in restorative practices i.e. apology letters, community service, building service, etc...
- Classes hear positive statements at a 3:1 positive to negative ratio.
- Students receive feedback, including praise, for effort and for engaging in desired behavior.
- On occasion, teachers contact parents **solely** to share positive news about their children.

### **Positive Behavior Intervention Supports**

Students respond to behaviour through positive rewards. This year W.R. James Elementary school will be starting a PBIS program promoting positivity through character education. Students will be rewarded for exhibiting STAR Jaguar Qualities throughout the day. Students will work on Understanding the Power of Three.

Students will learn routines and procedures.

#### VI. ROUTINES OR PROCEDURES

#### **Hallway Movement**

- Safe, quick travel at school gives scholars more time to learn
- Teachers should assign students a line order

#### Specific Student Behaviors:

#### In the halls our stars...SHINE

• Stay on the right

- Hands at your sides
- In a straight line
- No voices
- Everytime
- Have a pass if you're not with your class.
- All passes should have name, date, designation, time and staff signature.
- Passes are to be issued for:
  - Main Office
  - Nurses Office
  - Bathroom –emergency complete the bathroom log, indicating the time you leave the room to go to the bathroom and the time they return.

(teachers will escort their classes to the bathroom at a specific time

#### **Classroom Entry**

• Entering class quickly and quietly gives scholars more time to learn.

#### Specific Student Behaviors:

- Enter quietly, in a single file.
- Go directly to your seat and unpack all items needed for the day. (students are not permitted to go back to the closet area)
- Wait for your group or row to be called to put your things away.
- Go to the closet area quickly and quietly.
- Place homework in the assigned location.
- Take your seat immediately.
- Begin working on \*Do Now within 2 minutes of class start time.
- If the need arises, follow routine to get the teacher's attention.
- Wait silently for the teacher to acknowledge and respond.

#### **Getting the Teacher's Attention**

Predictable, non-intrusive ways to get the teacher's attention maintains a focus on learning.

#### Specific Student Behaviors:

- Raise your hand with an open palm to respond to a question, or make a comment during instruction.
- Wait for the teacher to respond. Use inside voices! No yelling out!
- Shake your fist to request to go to the bathroom.
- Raise hand with 1 finger up to request to get water. Wait for the teacher to respond.
- Raise hand with 2 fingers up to request supplies (pencil, tissue etc.). Wait for the teacher to respond.
- Each teacher will be given a poster with the hand signals to place in the classroom.

#### **Cafeteria**

• To promote a safe and orderly place for students to eat and socialize with their peers.

#### Specific Student Behaviors:

In the cafeteria our STARS...SOAR

- Stay seated
- Only inside voices
- Ask permission to get up
- Respect all
- Enter cafeteria through right hand side of double doors in a single file line with your class
- Teacher will escort class to the lunch line
- After getting lunch tray, walk to assigned table
- While eating students will:
  - o Follow directions from adults the first time they are given
  - Get quiet immediately after hearing the attention-getting signal

• Bathrooms should be handled before lunch by the classroom teacher. Emergencies only during lunchtime. You must have permission from the adult in charge.

#### Recess

 A recess routine will provide an outlet for students and a behavior modification strategy for teachers. Students will be more engaged in their lessons if they have a chance to expend some physical energy.

#### Specific Student Behaviors:

- Students who followed the school wide rules for the day should be allowed recess.
- If a student has not complied with the school/class rules they should be sent to a buddy teacher during recess or they can stand on the wall.
- Walk outside in a line with your lunch aid or the climate specialist during your designated time.
- Play only on the designated area outlined by the Climate Specialist.
- Hands, feet, and objects should be kept to yourself
- No horse play, hitting, inappropriate language, or use of electronic devices
- Immediately report any problems or injuries to an adult
- Line up immediately upon hearing whistle blown
- Walk quietly into the building after recess so as not to disturb classes in session

- Be on time and prepared
- Work at the task to be accomplished
- Think before you act

#### Respect Others

- Be safe, keep your hands to yourself
- Speak kind and positive words to others
- Respecting other's personal space

- Show pride for your school

#### V. SCHOOL WIDE PROTOCOLS FOR ATTENDANCE & INSTRUCTION

#### **Attendance**

#### "Attendance Matter"

- We ask that students not arrive at school earlier than 8:40 a.m. Staff supervision will begin at 8:40 a.m. In addition, students will not enter the building until 8:45 a.m., unless the outdoor temperature is 32° or lower, in which case, students will enter the building at 8:40 a.m.
- Parents are asked to call the school office between 8:00 am and 9:00 am on the morning that your child is absent from school to report student absences.
- Lateness to school is defined as not being in the assigned classroom at 8:55 a.m. In addition, parents must complete the *Student Sign-in Register* for students arriving after 8:59 a.m. Students in grades two through four will be assigned a general detention for every time they exceed three (3) late arrivals in any one month.
- Parents wishing to have their student dismissed early from school must sign-out students from the Main Office, after presenting appropriate identification. No early dismissals will be made after 3:00 pm or after 1:00 pm on half days. After 3:00pm (or 1:00pm) parents and students must wait until the normal school dismissal time.
- Parents/guardians are expected to pick students up promptly at 3:20 pm (or 1:20 pm Early Dismissal) or at the designated conclusion of an afterschool activity. Parents/ guardians who fail to pick students up within ten (10) minutes of the closing time will be required to complete the *Student Sign-in Register*. In addition, when three (3) late pick-ups have been recorded in any one month, a notice will be sent to the local child welfare agency documenting the late pick-ups.
- When picking-up or dropping-off your child by car, please DO NOT pick-up or drop off students in the fire zone/bus
  lane. In addition, please do not allow your child to exit your vehicle in an unsafe area on the street. Please be
  compliant with Parent Volunteers and local traffic guards who monitor traffic and work to ensure the safety of our
  students.

### PARKING LOT SAFETY

Please use extra caution when driving through the parking lot. Be sure to come to a complete STOP at the crosswalks. 3rd and 4th grade drop off will enter into the lane closest to Pine Tree Lane. 1st and 2nd Grade will drop off in the lane closest to the school. 3rd and 4th grade students will drop off near the main entrance. 1st and 2nd grade students will drop off near the multimedia center.

#### **Student Arrival**

We ask that students not arrive at school earlier than 8:40 a.m. Staff supervision will begin at 8:40 a.m. In addition, students will not enter the building until 8:45 a.m., unless the outdoor temperature is 32° or lower, in which case, students will enter the building at 8:40 a.m.

## **Reporting Student Absence**

Parents are asked to call the school office between 8:00 am and 9:00 am on the morning that your child is absent from school to report students absences

### **Lateness to School**

Lateness to school is defined as not being in the assigned classroom at 8:55 a.m. In addition, parents must complete the *Student Sign-in Register* for students arriving after 8:59 a.m. Students in grades two through four will be assigned a general detention for every time they exceed three (3) late arrivals in any one month.

## Late Pick -Up

Parents/guardians are expected to pick students up promptly at 3:20 pm (or 1:20 pm Early Dismissal) or at the designated conclusion of an afterschool activity. Parents/ guardians who fail to pick students up within ten (10) minutes of the closing time will be required to complete the *Student Sign-in Register*. In addition, when three (3) late pick-ups have been recorded in any one month, a notice will be sent to the local child welfare agency documenting the late pick-ups.

## **Early Dismissal**

Parents wishing to have their student dismissed early from school must sign-out stu dents from the

Main Office, after presenting appropriate identification. No early dis missals will be made after 2:00 pm or after 12:00 pm on half days. After 2:00pm (or 12:00pm) parents and students must wait until the normal school dismissal time.

## **Visitors**

- 1. All persons visiting the school are required to report to the Principal's office upon arrival.
- 2. All visitors will sign the visitors' register. The register will indicate the date, time, and length of visit, as well as the visitor's name and purpose of the visit.
- 3. Visitors will receive a pass as well as guidance or direction to their destination. 4. Staff and students are asked to direct unauthorized visitors to the Main Office.
- 5. Visitors will return their pass to the office before leaving.

### **Student Illness**

The following health protocol will be followed:

If your child has developed any of the following symptoms during the previous 24 hours, he/she should remain at home the next school day:

- Fever of 100° F or higher. The temperature should be normal for 24 hours before returning to school.
- ◆ Congestive Cough
- Vomiting
- Diarrhea
- ◆ Discharge that is other than clear from nose, eyes, mouth, ears or any other areas ◆ Skin rash

If a student comes to school but develops any of the above symptoms, the parent/ guardian will be notified and expected to take your child home. If the parent/ guardian cannot be reached, the available emergency contact will be called.

When, in the judgment of the school nurse, the student's teacher, and/or the building principal, a student shows signs of being in ill health as indicated below, the parent will be notified and expected to take the student home.

A student will be sent home if any of the following conditions are present:

- Fever of 100° F or higher. The temperature should be normal for 24 hours before returning to school.
- The student is unable to function/participate in the school activities due to ob served health status
- ◆ The student wants to sleep during the day and appears listless ◆ The student has a discharge which is other than clear from the nose, mouth, eyes, ears, or any other areas
- The student is vomiting
- The student has diarrhea
- The student has a congestive cough which prevents him or her from a meaningful involvement in the educational process

- ◆ The student has an open, draining sore and will not keep the bandage on ◆ The student had a previously controllable medical condition and that condition has become unmanageable (e.g. asthma, seizures)
- The student exhibits unusual pallor or a flushed faced
- The student has an unknown rash
- The student has a strong offensive body odor suggestive of urine/fecal soiling or hygiene concerns

#### **CELL Phones**

while the pupil is in the school building and may only be turned on after school has concluded for the day and the student is outside the school building. The school accepts no responsibility for lost, stolen, or misplaced cell phones.

### **Student Riding Bicycles**

Students in Grade 3 and above may ride bicycles to school if parents have a signed letter/permission slip on file in the Main Office. Students must ride with the traffic and lock their bicycle to the bicycle rack. State law requires all children under the age of 14 to wear a helmet when riding a bike.

## Harassment, Intimidation, & Bullying Anti-Bullying Specialist

W.R. James Elementary School expects students to show consideration to others, to be polite and respectful to all staff members and all fellow students. Acts of harassment, intimidation or bully ing will not be tolerated. This behavior, like other disruptive behaviors interferes with a supportive learning environment.

Harassment, intimidation and bullying are defined as any gesture, any written, verbal or physical act that is reasonably perceived

as being motivated either by any actual or perceived characteristic, such as race, color, religion, ancestry, national origin, gender, sexual orientation, gen der identify and expression, or a mental physical or sensory disability, or by any other distinguishing characteristic that takes place on school property, or at any school-sponsored function or on a school vehicle.

#### 2021-2022 School Level Parent Involvement Plan
