Plan Summary 2021-2022

General Information

A description of the LEA, its schools, and its students.

The Lemoore University Elementary Charter School (UCS) is a 6th through 8th grade dependent charter school of the Lemoore Union Elementary School District (LUESD) serving up to 180 students. Students in grades 6th thru 8th have a daily period rotation in five core academic classes along with an elective rotation and weekly workshops for differentiated instruction and intervention. The mission of the school is “To ensure that every student learns to his or her greatest potential.” The goal for staff is to support all students in their quest to be college and career ready. Students enrolled at UCS are majority residing within the LUESD boundaries.

The LUESD is located in the city of Lemoore in Kings County which is nestled in the heart of the San Joaquin Valley. Lemoore is an intimate farming community of 26,000 (pop.) with a Naval Air Station located just 7 miles west of town and is home to the Super Hornet F-18 Fighter Squadrons. Lemoore is centrally located in California approximately 3 hours north of Los Angeles and 3 hours southeast of San Francisco. The Central Valley stretches from Redding to Bakersfield and is internationally known as the largest fertile valley in the world. Most students attend 9th through 12th grades at Lemoore High School with a small population attending the Middle College program located on the West Hills College campus. West Hills College is a community college based in Coalinga, California that currently operates a comprehensive campus in Lemoore. California State University, Fresno, and Fresno Pacific University are located within an hour from Lemoore.

The LUESD staff are dedicated to serving the students of Lemoore and are guided by the district's goals, beliefs and values as noted below.

A review of the California School Dashboard (CSD) most recently updated data shows that UCS has met all local indicators. The CSD was suspended for the 2020-2021 school year and limited to local indicators for the 2019-2020 school year. The following information reflects a review of the 2018-2019 data. UCS earned Green status for Suspension and Yellow status for ELA and Math.

Reflections: Identified Need

A review of the CSD for the most recent reported data was from the 2018-2019 school year. This data indicates that the following areas need significant improvement: Chronic Absenteeism (Orange), while some continued focus on math and ELA is warranted. Low-income is the only unduplicated group with significant population size to be indicated as a performance group at UCS. Student groups performing in Orange or Red status were determined to be groups needing improvement. In the area of Chronic Absenteeism, the student group with the greatest need are Low-income students and White students (Orange). In the area of ELA, the student group with the greatest need are Low-income students and Hispanic students (Orange). In the area of math, the student group with the greatest need is Hispanic students (Orange).

For Chronic Absenteeism, the school is supported by the LUESD with Attention 2 Attendance information system to help with timely and effective communication with families regarding student absences. The school intervention team meets at least monthly to review absences and plan interventions to improve student daily attendance.

For ELA and Math, the school schedule includes additional tutoring opportunities for collaborative teams to work with small-groups and/or individual students in a tiered support system. Weekly collaborative team meetings are scheduled for instructional staff to work with teachers deconstructing the essential standards to identify essential skills, learning targets and expected proficiency targets for each ELA and math standard to assist teachers and students increase the rigor and support of academic instruction.

University Charter School (UCS) Charter Council meets quarterly. This council includes representatives of parents, teachers and staff. During regular meetings in February and April of 2021, the Council heard reports on the areas of concern regarding student progress and learning loss as impacted by COVID-19. The school leadership team meets monthly. Members include teacher and staff representatives. During regular meetings in March and April of 2021, the team discussed areas of concern regarding student progress and ideas regarding supplemental instruction and support strategies. Staff meetings are held monthly for all instructional staff. At the April 2021 meeting the staff shared areas of concern regarding student learning loss and ideas and suggestions to supplement instruction.

A summary of the feedback provided by specific stakeholder groups.

The feedback from our stakeholder groups focused on continuance of our current plan. The goal is to focus on student learning by providing time for teacher collaboration to plan for rigorous instruction aligned with the essential standards.

A description of the aspects of the LCAP that were influenced by specific stakeholder input.

Areas of the LCAP that were influenced by the stakeholder input included:

Goal 1: Support for actions noted by maintaining that all students have access to a mobile device, supplemental instructional support for students needing addition help in academic and behavior interventions, and that materials and supplies are made available to facilitate this goal. These actions were developed as a result of feedback from Charter Council members and UCS staff.

Goal 2: Support for actions noted by ensuring adult supervision during lunch breaks and providing access to a school counselor on a weekly basis. These actions were developed as a result of feedback from Charter Council members and UCS staff.

University Charter School supports the educational program of approximately 160 students on one campus. The student population of UCS consist of three significant student groups as defined by the state of California Department of Education. These include Low-Income, Hispanic, and White as well as the All Students group. The qualifying unduplicated student group identified at UCS is the Low-Income students.

Goal 1

Action 1.1: Student Technology - Provide, update and replace student mobile devices as needed to maintain a 1:1 model. Access to technology is an everyday expectation in our current world. To ensure low-income, foster youth, and English Learners will be the primary benefactors, the school plans to maintain and provide a mobile device so that each student has access to technology.

Action 1.2: Paraprofessionals - Trained paraprofessionals provide intervention services to students identified for tiered intervention in math or ELA. To ensure that each student is learning, supplemental instruction will be provided to any student needing additional support. To ensure low-income, foster youth, and English Learners will be the primary benefactors, all student groups will benefit from this tiered level of support to help address the achievement gaps that exist with some of our identified groups.

Action 1.3: Intervention Materials - Instructional materials and supplies to support the tiered academic and behavior supports. To facilitate a tiered structure of support, supplies and materials needed to insure that any student in the school has access to meet their needs. To ensure low-income, foster youth, and English Learners will be the primary benefactors, all student groups will benefit in the assurance that lack of supplies or materials to meet grade level expectation and decrease the achievement gap will not be factor.

Goal 2

Action 2.1: Noon Aide - Provide an adult yard supervisor to facilitate a positive school climate. Adult supervision is essential in establishing and maintaining a safe and nurturing environment. To ensure low-income, foster youth, and English Learners will be the primary benefactors, students in all groups will benefit from the assurance that adult supervision is available during all parts of the school day.

Action 2.2: School Counselor - Provide counseling services 1 day a week to all pupils in need. To provide counseling services on a weekly basis for low-income, foster youth, and English Learners as the primary benefactors for ongoing support of matters affecting all students experiencing trauma.

University Charter School has calculated supplemental and concentration funds to be \$122, 304 based on the number of Low Income, Foster Youth, and English Learners per 5CCR 15496(a)(5). The percentage of students that are identifiable as unduplicated are 51.43%. Actions will be utilized in a school wide manner, based on low-income, foster youth, English learner needs and stakeholder input.

Many of our students demonstrate high academic needs, especially in math, that show up as large academic achievement gaps across a variety of assessments. Furthermore, these academic challenges later result in disengagement from learning in the classroom and distancing from the school which shows up as increased truancy and absenteeism. Social-emotional health issues underlie all of these student behaviors.

We have worked to provide increased and improved services to our highest need students. Actions that were implemented in previous years have been analyzed and quality improvements have been made based on the identified needs of our low-income, foster youth, English learners, and stakeholder input.

We have included all actions that are used to contribute to meeting the minimum proportionality, or increased improved services provision, within our LCAP. All actions were aligned to the areas within the plan, support the contextual need of our students, and set foundations for the continuance of learning.

The actions we are carrying over from our 2019-2020 LCAP and/or 2020-2021 LCP to provide services for foster youth, English learners and low income students include:

- Provide, update and replace student mobile devices as needed to maintain a 1:1 model.
- Trained paraprofessionals provide intervention services to students identified for tiered intervention in math or ELA.
- Instructional materials and supplies to support the tiered academic and behavior supports.
- Provide an adult yard supervisor to facilitate a positive school climate.
- Provide counseling services 1 day a week to all pupils in need.

Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action(s))

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100% attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
