Parents: Please complete this short check each morning before your child leaves for school. If your child exhibits any symptoms, help protect all of our students and staff members and keep your child home from school.

Symptoms: If your child has any of the following symptoms, that indicates a possible illness that may decrease the student's ability to learn and also put them at risk for spreading illness to others.

Please check your child for these symptoms:

- Temperature 100.4 degrees Fahrenheit or higher when taken by mouth
- Sore throat
- New cough that causes difficulty breathing (for students with chronic allergic/ asthmatic cough, a change in their cough from baseline)
- Diarrhea, vomiting, or abdominal pain
- New onset of severe headache, especially with a fever

S Y M P T O M S

of COVID



- Cough, shortness of breath, or difficulty breathing
- Fever or chills
- Muscle or body aches
- Vomiting or diarrhea
- New loss of taste or smell

Symptoms can range from mild to severe illness and appear 2-14 days after you are exposed to the virus that causes COVID

Emergency Warning Signs

Seek medical care immediately, if someone has:

- Trouble breathing
- New confusion
- Persistent pain or pressure in the chest
- Inability to wake or stay awake
- Pale, gray, or blue-colored skin, lips, or nail beds, depending on skin tone

C L A S S R O O M S



- Physical distancing when possible, according to updated guidance
- Ongoing cleaning and disinfecting will be conducted by the custodial staff
- Students are encouraged to bring their own water bottle for use each day. Water bottles can be filled in the school's water bottle filling station.
- Handwashing and/or hand sanitizer is provided for each classroom
- Individual desk screening will be provided for elementary students, if requested.
- The person who tests positive for COVID is required to isolate at home for 5 days following a positive test. A person who is immunosuppressed or was hospitalized may need a longer isolation period.
- The School District Dashboard will only reflect positive cases of students and staff, as quarantines are no longer required.

F A C E M A S K S



- While on school grounds, attending events, or utilizing district transportation, **the use of masks shall be optional.**
- Center for Disease Control, American Academy of Pediatrics, Arkansas Department of Health, and the Arkansas Department of Education encourage all non-vaccinated persons and children under the age of 12 to wear masks, however, this is not a requirement.
- Individuals exposed to a confirmed case of COVID will not need to be quarantined.
- We strongly encourage students and staff to stay home when sick.
- We will encourage, support and show kindness to the choices each family makes in regards to mask wearing. Actions inconsistent with this will not be tolerated.
- When attending events at visiting schools that have a required mask mandate, Gravette Lion students and families will graciously follow their policy.

V A C C I N A T I O N S



- According to the CDC, COVID vaccines are the most effective strategy to protect people from getting sick and to reduce the risk of people spreading COVID.
- Students age 12 and older are eligible to receive the Pfizer vaccination.
- Vaccination for eligible students and adults is encouraged, but not required to attend Gravette Schools.
- Students or staff do not need to quarantine if deemed close contacts, unless they have/develop symptoms.
- We will encourage, support and show kindness to the choices each family makes in regards to vaccines. Action inconsistent with this will not be tolerated.

V I S I T O R S

- Visitors must adhere to the same expectations as students and staff.
- **Visitors should screen themselves at home prior to coming to school.**
- Any visitor showing signs/symptoms of COVID should remain home.
- Visitors must check-in at the main entrance to each school building upon arrival.
- Parents/guardians are allowed to have lunch with their student(s). Specialized seating will be provided away from other students to maintain physical distancing, when possible.
- Virtual meetings with parents/guardians may be scheduled in lieu of face to face conferences.
- In person meetings should utilize at least 3 feet distancing for all participants.
- Non-essential visits to campus such as classroom visits, escorting students to class, etc. are prohibited. If there is an extenuating circumstance, please contact your child's principal.
