## **Superintendent's Comments**

Dr. McNulty thanked Ms. Robinson for her shout-out and reiterated her statement about District staff. He stated that we are committed to staff, to students and the families of the District.

Dr. McNulty stated that successes are directly related to commitment and that it was his honor to serve the District. He shared that the District participated in Grandparent's Day and that he attended the celebration at College Station Elementary and acknowledged Ms. Ward's attendance as well. Dr. McNulty also stated that Meet the Teacher (Parent/Teacher Conferences) were Wednesday, September 16th and for parents to take advantage of that and for us to rejoice in the successes kids are having. He then yielded his time to Dr. Smith and Jessica Duff.

Ms. Duff shared that Dr. McNulty and herself had been selected and recognized across the city and state respectively. Dr. McNulty was selected as "Man on a Mission" by Little Rock Soiree magazine and will be featured in the November issue. Ms. Duff was selected as a Arkansas Top 100 Professionals and will be featured in the October issue.

Dr. Smith shared that she and Dr. McNulty have visited every school in the District, including the middle schools as they are implementing the block schedule, and are completing an audit of the building and the classrooms and has seen amazing things. She shared that she and Dr. Luttrell have met with each school's leadership team, i.e. administration and coaches to ensure that expectations are communicated and being met. Dr. Smith added that the MAPP assessments are complete, CFA's are being completed and the PLC's are happening. She stated that 30-day action plans are next; teachers are working hard and administrators are keeping students and staff safe.

Dr. McNulty added that he taught in Coach Flowers' Civic's class at Mills High School this week and interacted with some amazing scholars.
