Minutes of the Public Hearing Serena Community Unit School District #2 LaSalle County, Illinois August 25, 2022

The Public Hearing was called to order at 7:00 p.m. held in the Serena High School Library of the Serena Community Unit School District #2, LaSalle County, Illinois (the "District"), 2283 North 3812th Road, Serena, Illinois regarding a plan to issue not to exceed \$15,000,000 in aggregate principal amount of the District's General Obligation School Bonds, Series 2022 (the "Bonds").

Gary McNelis, President, as Hearing Officer read the following statement:

Good evening, ladies and gentlemen. This hearing will come to order. Let the record reflect that this is a public hearing being held pursuant to the requirements of Sections 10 and 20 of the Bond Issue Notification Act of the State of Illinois, as amended. Notice of this hearing was published on August 4, 2022, in The Times, a newspaper of general circulation in the District. This is a hearing regarding a plan to issue not to exceed \$15,000,000 in aggregate principal amount of the District's General Obligation School Bonds, Series 2022 (the "Bonds"). The proceeds of the Bonds will be used to (i) pay certain claims of the District in an amount not to exceed \$10,000,000, said claims being the District's outstanding General Obligation (Limited Tax) Debt Certificates, Series 2022, dated July 26, 2022, (ii) to create or increase the working cash fund of the District in an amount not to exceed \$5,000,000, and (iii) pay certain costs of issuance of the Bonds.

The Bonds will be issued by the District in accordance with the provisions of Article 19 of the School Code of the State of Illinois, as supplemented and amended, and shall constitute a general obligation of the District, payable from ad valorem property taxes levied against all of the taxable property in the District without limitation as to rate or amount.

This public hearing is required by Sections 10 and 20 of the Bond Issue Notification Act of the State of Illinois, as amended. At the time and place set for the public hearing, residents, taxpayers and other interested persons will be given the opportunity to express their views for or against the proposed plan of financing, the issuance of the Bonds and the purpose of the issuance of the Bonds.
