Students of the Month and the Staffulty Award winner were recognized.

2023 Tax Levy – Increased EAV (Equalized Assessed Value) for all properties in the area could result in a higher tax bill for residents, but this is not due to the District's levy. The District levied lower this year than last, which means \$4.28 of taxpayers' total tax bill goes to the District. Other municipalities can still cause an increase in the overall tax bill.

President G. McNelis requested public comment. There was none.

Board-Teacher-Administrator Committee – The group gathered for an initial roundtable discussion on December 6. The Union Leadership Team and the Superintendent will meet monthly to address any specific district concerns. Dates for collaborative and continual conversations were established.

## **Discussion/Informational Items:**

Therapy Dog Program – Shelli Ocepek, a representative from the United Way of Eastern LaSalle County, reached out to the District regarding their therapy dog program. This program is fully funded by the United Way but requires the District to have a primary and secondary handler. The dog would live with the handler when not at school. Additional information is needed before a final decision can be made.

Foundation Scholarship – Scholarship packets will be distributed to students in February.

Donations — Additional donated books through the Aurora Retired Teachers Association have been delivered. To date, Serena has received over 250 books from this organization. Blick's Art Supply has three pallets of art supplies to donate to the District again this year with a value estimated to be over \$10,000. The Husker Hearth has received monetary donations from several organizations, individuals, and families.

Husker Hearth – A local investor, Resource Bank, and Northern Illinois University representatives met with the Superintendent on December 13 to discuss initial ideas about an edible campus at Serena. More information regarding the scope of this project will be presented at the February Board meeting.
