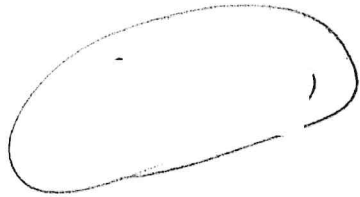

The Board returned to Regular Session at 8:00 pm.

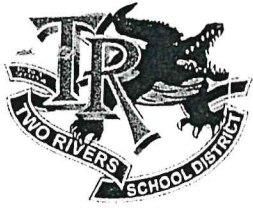
