SUCCESS STORY: JUNIOR HIGH BAND STUDENTS HAVE GREAT SUCCESS In early January 2020, District #108 band instructors Mr. Sheldon and Miss Hendrick began work on three pieces for students to take to the I.G.S.M.A (IL Grade School Music Association) Organizational Contest in Germantown Hills. Students who compete in the Organizational Contest are expected to perform a selection of pieces in front of three judges with a high level of discipline, artistry, and musicianship, in hopes of receiving a Division 1 rating (the highest award possible). Students do not actually compete against other schools in this competition, but against themselves. Each participating school is capable of attaining a Division 1 rating if they prepare in the way Pekin District #108 band students prepared.

After Pekin's performance, they received two perfect scores and one almost perfect score from the judges. During Miss Hendrick's tenure in Pekin D108, the band has always shown a high level of excellence, receiving a Division 1 rating almost every year, but the performance this year was exceptional as the Division 1 score was the highest score the band has ever received.

Additionally, Pekin was the second largest group in attendance with other notable area directors stating "this was one of the best junior high groups we have heard in a long time."

All students must learn their parts to the best of their ability in order for the group to succeed. Miss Hendrick worked with students during full band rehearsals, brass lessons, and percussion lessons, while Mr. Sheldon worked with students during woodwind lessons. The students also spent a great deal of time at home learning, practicing, and preparing their music for this contest.

While Miss Hendrick and Mr. Sheldon are pleased with the score the students received, they are most excited that the students were able to learn that their success was due to their dedication to band rehearsals and lessons, as well as their discipline, perseverance, and the effort they put forward each time the group rehearsed.
