 - M. Pouliot advised most comments were around the first goal and Orton Gillingham. L. Carey made revisions and the committee added more in Orton Gillingham instruction.
 - L. Carey plans to bring the Strategic Plan back to the Board on an annual basis. The Board will be informed of the progress. Wants to let the Board know what is working, not working, etc. There will be annual meetings to update the living document. She would be happy to have a meeting, including the Board, to work on updates. Advised there are different grant sources to fund from.
