IN THE MATTER OF Review of Mask Requirement:

Jeff Holt presented mask information and recommendation from the RSD Leadership

Team.

40% mask requirement 30% hybrid mask 28% option masks 89% bus drivers – optional for masks 81% building leaders

Proposed policy: Mask will be strongly recommended but not required through the first semester with adjustments to be made as needed. District Mask Policy stating that when a building's population (staff & students) is identified as having 2% or higher of positive cases OR 10% of the total population is quarantined, masks will be required for 3 weeks within that building. Building will stay in *required* status until numbers are back below 2% positive or 10% quarantined

Jeremy Keaster asked if the 3-week mask requirement could be changed to 2 weeks instead.

Annie Schanink explained that having a bigger window would catch more students who might show symptoms later.

6:20 p.m. Jason Golden opened the floor to allow public comments for 3 minutes each regarding the mask requirement.

    - Morgan Barrett said if we are taking the recommendation from the admin we should accept it, not modify it. I'm not sure I can support.

- Holli Hall wanted more clarification on quarantines. If one has on a mask around a positive who is not masked, do they have to quarantine?
  - Annie Schanink, yes both have to have the mask on properly.
  - Holli Hall This will cause more quarantines with optional masks. Our goal is to keep students in school learning, regardless of how we feel about masks.
  - Morgan Barrett Important to note that masks have to be worn properly, and the elementary kids can't, and the secondary kids won't.
  - Holli Hall would like to keep the mask requirement for 12 and under for the next 30 days.
  - Jeremy Keaster the threshold is the recommendation.
  - Mr. Vining with this policy masks are still strongly recommended.
