#### **BOARD NOTES...**

The Decatur City Board of Education met in regular session on Tuesday, October 19<sup>th</sup> at 4:00 p.m. in Alumni Hall at Decatur High School. Board members present were Michele King, Dwight Jett, Doug Bachuss, and Jason Palmer. Dr. Michael Douglas and Mrs. Mandi Jones were also in attendance. Mrs. King did mention that Mrs. Baggett had a family emergency and was unable to attend.

The Board started the meeting by reciting our mission statement. "The mission of Decatur City Schools is to provide an innovative learning community committed to academic excellence and meeting the unique needs of every individual."

Minutes from the September 14, 2021 regular session and the September 28, 2021 special sessions were approved as distributed.

Dr. Douglas asked Mrs. Jones to present the financial statements for the eleven months ended August 31, 2021. The general fund ended the month with revenues exceeding expenditures by \$1,209,010, increasing the fund balance to \$25,884,609. The Child Nutrition Program statement reflects revenues in excess of expenditures for the month of \$487,525 and an ending fund balance of \$1,627,659. The financial statements and bank reconciliations were approved as submitted.

Dr. Douglas presented the certified and non-certified personnel agenda and it was approved as presented. He took a moment to recognize a couple of retirements.

Myra Whitfield – Special Services - 20 years of service Sara Hendrix – Banks-Caddell - 9 years of service

Next, Dr. Douglas presented the Technology Coordinator Salary Schedule. It was approved as submitted. He explained that we renamed the position when Mrs. Elam left due to the State providing funding for the job title of Technology Coordinator.

Dr. Douglas asked Dr. Melissa Scott to present the ACIPs for the 2021-2022 school year. Dr. Scott reviewed all of the training and prep work that went into getting the ACIPs ready and submitted to the State. The Board thanked Dr. Scott for all of her work as the new Federal Programs Supervisor. The ACIPs were approved as submitted.

Dr. Douglas asked Mr. Satterfield to present the policy revisions for a second reading. Mr. Satterfield presented the following policy revisions and noted that there were only 2 small changes from the first reading. The policies were approved as submitted.

Dr. Douglas asked Mr. Keenum to present the CIPA Compliance to the Board. Mr. Keenum explained to the Board that State requires us to review CIPA (Children's Internet Protection Act). Mr. Keenum went through the slides from the State and gave the Board details on measures that we have in place. This was only for their information and a vote was not required.

Last, Dr. Douglas presented to the Board that we move to "masks preferred" starting November 1<sup>st</sup>. Dr. Douglas asked Mr. Satterfield to explain to the Board how we got to this point. Mr. Satterfield explained that we started school "masks optional" and within the first two week we moved to "masks required". Mr. Satterfield stated that we spoke with our attorney prior to the switch and the way our Board Policy is written Dr. Douglas didn't have to have a Board vote. However, he did let President King know ahead of time. Since there has been some confusion in the community, Dr. Douglas decided to bring "masks preferred" to the Board for a vote. The Board to approve the recommendation of "mask preferred" starting November 1<sup>st</sup>.
