

MINUTES OF REGULAR MEETING OF THE BOARD OF EDUCATION OF  
PINCKNEYVILLE COMMUNITY HIGH SCHOOL DISTRICT #101, PERRY COUNTY,  
ILLINOIS, HELD ON THE 24th of MAY, 2021, AT 6:30 P.M. IN THE PINCKNEYVILLE  
COMMUNITY HIGH SCHOOL BUILDING IN THE PINCKNEYVILLE SCHOOL  
DISTRICT.

The Board of Education of Pinckneyville Community High School District #101, Perry County, Illinois, met in a regular session on the 24th of May, 2021, at 6:30 p.m. at the Pinckneyville Community High School in that district. The following officers and members of the Board were present: President Brian Kellerman, Jennifer Robb, Lisa Stanton, John Morgan, Curtis Miller, and Kyle Pursell. Greg Bigham was absent. Superintendent Keith Hagene, Principal Tony Wilson, and Secretary Penny Corn, were also present. Roll call was conducted at 6:36 pm.

The Pledge of Allegiance was conducted and PCHS Mission Statement was read by President Brian Kellerman.

The improvements in the science lab are complete, and the new Promethean Boards should be installed soon. Upcoming projects include replacing seats in Thomas Gym, and updating the PCHS weight room.
