

MINUTES OF REGULAR MEETING OF THE BOARD OF EDUCATION OF
PINCKNEYVILLE COMMUNITY HIGH SCHOOL DISTRICT #101, PERRY COUNTY,
ILLINOIS, HELD ON THE 26th of APRIL, 2021, AT 6:30 P.M. IN THE PINCKNEYVILLE
COMMUNITY HIGH SCHOOL BUILDING IN THE PINCKNEYVILLE SCHOOL
DISTRICT.

The Board of Education of Pinckneyville Community High School District #101, Perry County, Illinois, met in a regular session on the 26th of April, 2021, at 6:30 p.m. at the Pinckneyville Community High School in that district. The following officers and members of the Board were present: President Greg Thompson, Brian Kellerman, Jennifer Robb, Lisa Stanton, and Kyle Pursell. Jeff Suchomski and Greg Bigham were absent. Superintendent Keith Hagene, Principal Tony Wilson, and Secretary Penny Corn, were also present.

The Pledge of Allegiance was conducted and PCHS Mission Statement was read by President Greg Thompson.

The Board reviewed the canvassed election certification documents, and acknowledged the results of the April 6, 2021 election as prepared and presented by the Perry County Clerk.

Newly elected Board members Curtis Miller and John Morgan were administered the New Board Member Oath of Office.

It was moved by Kyle Pursell and seconded by Jennifer Robb to adjourn for a short recess at 6:37 p.m. Voice vote. All ayes. Motion carried.

Meeting was reconvened and Brian Kellerman was appointed as temporary president until the permanent office was filled.

Meeting was called to order by President Pro-Tem Brian Kellerman. Roll call: Lisa Stanton, John Morgan, Kyle Pursell, Jennifer Robb, Curtis Miller, and Brian Kellerman were present. Keith Hagene, Superintendent, Tony Wilson, Principal, and Penny Corn, recording secretary, were also present.

Brian Kellerman was nominated for the office of President. No other nominations were made.

New Board President Brian Kellerman called the meeting to order at 6:46 p.m.

Visitors present; Marilyn Smith, Dan Herbst, and Stuart Morgenstern. Visitors were welcomed and invited to address the Board. No comments were made.

Mr. Wilson reported that winter sports have finished their seasons, and spring sports season is beginning this week. He announced that we have 10 Illinois State Scholars this year. We will have credit-recovery classes in English, Science, Social Studies, and Math available this summer.

Mr. Hagene explained legislative topics relevant to schools, and talked about grants he has recently written. He talked briefly about flat funding and evidence based funding which could affect our future budgets.

The office floors and drains in Thomas Gym are complete, and the science lab improvements are set to begin soon. Classroom Smartboards are going to be replaced with Promethean ActivPanel Boards.
