

Wall ISD Charge Policy

Dear Parents/Guardians,

Wall ISD strives to provide students with nutritious meals for breakfast and lunch. In providing these meals, the National School Breakfast and Lunch Program has implemented guidelines. Wall ISD abides by these guidelines.

Texas Department of Agriculture implemented charge policy guidelines that are mandatory. School district charge policies must be implemented and enforced by all school districts participating in the National School Breakfast and National School Lunch Program.

The Wall ISD charge policy is as follows:

Students may charge up to \$6.00. When this charge allotment is exceeded, students will be offered a meal of peanut butter, crackers & an apple. A meal of cheese, crackers & an apple will be offered to students with peanut allergies.

Please note: Three weeks prior to the end of each semester charges are not allowed.

Wall ISD charge policy is not intended to embarrass students. It is intended to provide a meal to students who are out of money and have exceeded the charge limit.

Wall ISD uses NutraKids Software Program for its meal payments. Online payments are offered using credit or debit card as well as in person with check or cash. It also allows parents to set up reminders emailed to them when their students are low on money. An automatic reoccurring monthly payment can also be set up. All these conveniences allow you to insure your student gets the best possible experience in the meal line.
