Minute 3: (Personnel). Mr. Penn called the board into executive session to discuss personnel at 6:28 p.m. Mr. Penn called the board into regular session at 7:35 p.m. No action was taken on personnel.

Minute 4: (October Minutes) Mr. Doyle made a motion to approve the October minutes. Mr. Randolph seconded. Motion carried (5-0) at 7:36 p.m.

Minute 5: (October and November Financial Reports) Mr. Penn made a motion to approve the October and November Financial Reports as presented. Dr. Perkins seconded. Motion carried (5-0) at 7:38 p.m.

Minute 6: (Certify Election) Mr. Parsley made a motion to certify the election results. Mr. Doyle seconded. Motion carried (5-0) at 7:38 p.m.

Minute 7: (Re-organize Board) Dr. Perkins made a motion to appoint Mr. Phillip Penn as President, Mr. Roger Randolph as Vice-President, Mr. Brent Glenn as Secretary, and Mr. Dean Parsley as Disbursement Officer of the Board. Mr. Doyle seconded. Motion carried (5-0) at 7:39 p.m.

Minute 8: (Benchmark Workshop) Mr. Crabtree recommended the purchase a six-year subscription to Benchmark Workshop at the purchase price of \$78,297.20, utilizing ARP "Loss of Learning" Funds. Mr. Crabtree told the board that DESE had approved the purchase with an email response. Mr. Penn made the motion to follow the recommendation. Mr. Randolph seconded. Minute 9: (Edgenuity) Mr. Crabtree recommended the board purchase a one-year subscription to Edgenuity for social-emotional resources for our staff and students to utilize at the purchase price of \$19,450.00 Mr. Crabtree told the board that DESE had approved the purchase with an email response.
