Dear Parents of CJ-I school,

It is that time of the year again to bring up the need for the seasonal flu vaccine. Liberty County Public Health Department is partnering up with the Blue Cross Blue Shield Care Van to provide seasonal flu vaccine on November 2nd, 2021 at the school. With your consent we can get your child his/her flu vaccine and keep them healthy this upcoming season. Here are some Flu facts provided below:

What is Influenza (Flu)?

Flu is a contagious respiratory illness caused by influenza viruses that infect the nose, throat, and sometimes the lungs. It can cause mild to severe illness, and at times can lead to death. The best way to prevent flu is by getting a flu <u>vaccine</u> each year.

Flu Symptoms

Flu can cause mild to severe illness, and at times can lead to death. Flu is different from a cold. Flu usually comes on suddenly. People who have flu often feel some or all these symptoms:

- Fever (It's important to note that not everyone with flu will have a fever.)
- cough
- sore throat
- runny or stuffy nose
- body aches
- headache
- chills
- fatigue
- · sometimes diarrhea and vomiting

What we're asking you parents to do is to check with your health insurance company and make sure that the flu vaccine will be covered by your insurance. We do have VFC (state supplied) vaccine that can be used, but we're not allowed to use it on children who have insurance coverage for immunizations. If you do not have health insurance that covers vaccinations, BCBS will pick that cost up for you, but only if you don't have insurance. Our goal here is to immunize as many school staff and children to prevent he spread of the seasonal flu this coming season.

Please look this information over, sign the information slip and provide the insurance information if applicable. Return this to Miss Marley at the elementary secretary office or Miss Abbey in the high school office by **NOVEMBER 1**st, **2021**.
