b. Review and Adjustment of COVID 19 Plan:

Discussion: The plan was adjusted on the fly, amended again by the board. Remote option is still in place. There was also a suggestion to bring the elementary students in 2 weeks earlier than the High School. A parent asked how will delaying make a difference? Ryan responded that it is our duty to act on the side of caution. It is better to overreact than to underreact. Ryan also explained that not all our PPE has arrived, and we need time to train our staff appropriately. Mr. Steeves responded that at this time we do not know how many staff have been affected with this recent outbreak. Another parent commented that this has been an eye opener for her, and she thanked everyone on the board for putting the staff and students need first.

The final recommendation and approval were as follows.

Region students can start remotely on September 8th. There will be a 2-week delay with online learning for the first 2 weeks for all students. After the first 2 weeks elementary students will start in house on September 28th and the High School will continue with remote learning until October 5th.
