# School District of Greenwood School Operational Plan 2021-2022

### **Weekly Schedule**

- In-person instruction 5 days per week for all students in grades 5K-12.
- 4K students will attend school all day on their assigned attendance days. Fridays will be family outreach days for 4K.

# **Transportation Plan**

- The district will follow the federal transportation guidelines. **Currently, masks are** required on buses until January 18, 2022.
- It is recommended that family members sit together on the bus.
- Parents are encouraged to maintain a consistent bus riding schedule.

# **Student Meal Plans**

- Breakfast and Lunch will be free for all students attending school in the School District of Greenwood during the 2021-22 school year.
- Specific cafeteria protocols for the elementary and high school will be communicated to students by the individual schools.

# **Daily Operation Plan**

- A daily self-screening symptom checklist will be sent to all families, students, and staff.
  No one should come to school if the symptoms checklist indicates the student or staff member should remain home.
- Masks are highly recommended for all students and staff by the CDC. Masks are not required. Masks will be available in the school buildings and on buses.
- If 5% of the total student population becomes positive for Covid-19 at any one time, a Special Board meeting will be called to discuss if a change in protocols is in order.
- The district will continue to limit non-essential visitors during school hours. Any approved visitors must follow all district safety protocols.

#### **Physical Spaces Plan**

- The district will look to maintain a minimum of six (6) feet of physical distancing to the greatest extent practicable.
- Plexi-glass barriers will be used in public spaces where advisable or requested.
- Safety signage for hand hygiene, protective measures and symptoms awareness will be displayed throughout the buildings.
- Sanitizing stations will be located at entry points and in hallways. Hand sanitizer will be available in all classrooms.
- Bottle filling stations are located throughout the buildings. Students may carry their own water bottles.

#### **Healthy Environments Plan**

- The district has established daily and weekly protocols for cleaning and disinfecting.
- Staff will continue to reinforce safety protocols.

### **Points of Contact Regarding Covid-19**

- Students and/or staff with 2 or more Covid-19 related symptoms will be sent home from school.
- Parents should contact their health care provider or the Clark County Health
  Department regarding Covid-19 testing options.
- The district will not participate in the State of Wisconsin's CVID-19: K-12 School Testing Program.

## Positive Case Isolation (per Clark County Health Department)

- Individuals (unvaccinated and vaccinated) testing positive will be required to isolate for 10 days from the onset of symptoms or positive test and must be symptom free for 24 hours without medication before returning to school.
- Students and/or staff with 2 or more Covid-19 related symptoms will be sent home from school.

#### Close Contact Quarantines (per Clark County Health Department)

- Individuals identified as close contacts who are not fully vaccinated will be required to quarantine for 14 days. Quarantined individuals must be excluded from in-person classes and extra-curricular activities.
- The 7-day and 10-day shortened quarantines options may be considered on a case-by-case basis.
- Asymptomatic close contacts who are fully vaccinated will NOT be required to quarantine.

#### **Remote Learning Option 2021-2022**

• If a family wants a remote learning option for the 2021-2022 school year, they must register for classes through the Rural Virtual Academy. Please contact the building principals for more information.

#### Vaccination

- All District employees were given the opportunity to be vaccinated in the spring of 2021.
- The District encourages parents to have their vaccine-eligible students vaccinated.
- The District distributes updated information from the Clark County Health Department on vaccine sites to families and staff.

### **Achievement Gap Recovery**

- The district has reduced class sizes to provide students to better meet student needs.
- The district will operate the following afterschool programs: Kids Club at the elementary level and Promoting Academic Success for Students (PASS) at the middle and high school level.
- The middle and high school has reintroduced the WIN (What Individuals Need) intervention time at the end of the scheduled day.

## **Continuity of Services Plan**

- The District's CSP addresses the following:
  - ➤ A transition to remote learning if in-person instruction is not possible;
  - A plan to provide services to specific students groups;
  - A plan to provide breakfast and lunch to district families if in-person instruction is not possible
- The District is integrating evidence-based socio-emotional wellness programs and events for students and staff.

#### **Plan Review and Revision**

- These plans are subject to change if conditions change.
- District guidelines will be reviewed and evaluated monthly by the School Board and administration.
- The District will make the Return to School plan available in other languages or formats upon request.
